Whereas the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") by the Unemployment Insurance (Insurance Industry Special Scheme) Orders (Northern Ireland), 1921 to 1938, approved for the purposes of Section 18 of the Unemployment Insurance Act, 1920, a Special Scheme for the Insurance Industry and varied and amended the said Scheme, which Scheme as so varied and amended is hereinafter referred to as "the Scheme";

And whereas it is provided by Sub-section (6) of Section 77 of the Unemployment Insurance Act (Northern Ireland), 1936 (hereinafter referred to as "the Act"), that for the purpose of securing in the case of a Special Scheme that like rates of benefit shall be payable to the persons to whom the Scheme applies, as are for the time being payable under the general provisions of the Act, or any amendment thereof, and that the benefits under the Scheme

shall otherwise be not less favourable than those for the time being provided by the said provisions, or any such amendent (but for no other purpose), the Ministry may, after consultation with the body charged with the administration of the Scheme, by order vary or amend the provisions of the Scheme;

And whereas for the purposes mentioned in the said Subsection (6) it is necessary further to vary and amend the provisions of the Scheme;

And whereas the Insurance Unemployment Board is the body charged with the administration of the Scheme;

Now, therefore, the Ministry, after consultation with the Insurance Unemployment Board, hereby makes the following Order :—

1.—The provisions of the Scheme shall be varied and amended as follows :—

Clause 37 of the Scheme shall have effect as if in sub-clause (2) (c) thereof for the expression "for every eight days" there were substituted the expression "for every ten days."

2.—This Order shall come into force on the date hereof.

3.—Nothing contained in paragraph 1 of this Order shall affect the computation of the maximum number of additional days in any claim year which began before 1st January, 1938.
