ORDER OF THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND, DATED JANUARY 1ST, 1938, UNDER SECTION 7 OF THE GAS REGULATION ACT, 1920, AS AMENDED BY SECTION 2 OF THE ELECTRICITY AND GAS (EXPENSES) ACT (NORTHERN IRELAND), 1923, PRESCRIBING THE RATE OF PAYMENT TO THE SAID MINISTRY FOR THE YEAR 1937.

Registration of Premises.

REGULATIONS, DATED 27TH DAY OF MAY, 1938, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 4 (1) OF THE SALE OF ICE-CREAM ACT (NORTHERN IRELAND), 1937.

1938. No. 67.

The Ministry of Home Affairs for Northern Ireland, in pursuance of the powers vested in it by Sub-section (1) of Section 4 of the Sale of Ice-cream Act (Northern Ireland), 1937 (hereinafter referred to as "the Act"), and of all other powers enabling it in that behalf, hereby orders and directs as follows :—

I. A person who is the owner or occupier of premises and who desires to have such premises registered for :---

(a) the manufacture of ice-cream for sale; or

(b) the sale of ice-cream;

shall make an application accordingly to the Sanitary Authority by sending a notice to the Clerk of such Authority, setting forth the following particulars with respect to the premises to which the application refers ;—

ICE-CREAM, SALE OF

(1) Full name of the applicant (surname first).

- (2) Address of the applicant.
- (3) Description and situation of the premises to which the application refers.
- (4) (a) Whether the premises are used or are proposed to be used for the manufacture of ice-cream for sale.
 (b) Whether the premises are used or are proposed to be
 - used for the sale of ice-cream.
- (5) Interest of the applicant in the premises, i.e., whether as owner or occupier.
- (6) If applicant is not the occupier, the name and address of the occupier.
- II. On receipt of an application for registration under Article I of these Regulations, the Sanitary Authority shall, subject to the provisions of sub-section one of section five of the Act, cause to be entered in a Register to be kept for the purpose the particulars set forth in the notice of application, together with the date on which the particulars are so entered.
- III. Where any premises have been registered in accordance with Article II of this Order, the Clerk or other authorised officer shall forthwith notify the person by whom application for the registration of the premises was made that the premises have been registered.
- IV. A person who becomes an owner or occupier of premises which have been registered in accordance with the provisions of this Order on the application of some other person who, at the date of such application, was the owner or occupier of the premises, shall, if he desires to use the said premises :---
 - (a) for the manufacture of ice-cream for sale; or
 - (b) for the sale of ice-cream;

make application for the registration of the premises in the manner set forth in Article I of this Order.

- V. The Sanitary Authority shall once in every year, and also from time to time as may be necessary, revise the register compiled in pursuance of Article II of this Order by deleting therefrom any entries relating to premises which have ceased to be used
 - (a) for the manufacture of ice-cream for sale; or
 - (b) for the sale of ice-cream.

VI. The Clerk or the authorised officer shall, on the application of any person, furnish him upon payment of a fee of 2s. with a duly certified copy of the entry relating to any premises made in a register in accordance with Article II of this Order.

VII. In these Regulations the expression "sanitary authority" means the Council of any county borough, borough, or urban or rural district, and the expression "clerk" means the clerk of the sanitary authority.

REGULATIONS, DATED THE 11TH DAY OF JUNE, 1938, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION TEN OF THE SALE OF ICE-CREAM ACT (NORTHERN IRELAND), 1937.

1938. No. 73.

The Ministry of Agriculture for Northern Ireland in the exercise of the powers conferred upon it by section ten of the Sale of Ice-Cream Act (Northern Ireland), 1937, and of every other power enabling it in that behalf hereby makes the following Regulations, that is to say :---

PART I.

GENERAL.

1.—These Regulations may be cited as the Sale of Ice-Cream short Regulations (Northern Ireland), 1938.

2.—(1) In these Regulations, unless the context otherwise Interpretation: requires :—

- "Act." means the Sale of Ice-Cream Act (Northern Ireland), 1937;
- "Ice-cream mixture " means the mixture from which icecream is manufactured before it has been subjected to any freezing or hardening process;
- "Ministry "means the Ministry of Agriculture for Northern Ireland;
- "skimmed milk " means milk from which substantially all the milk fat has been removed and includes separated or machine skimmed milk;
