## LOCAL GOVERNMENT

WHEREAS the Ministry of Home Affairs for Northern Ireland (hereinafter referred to as "the Ministry") by virtue of the powers vested in the Ministry by the Local Government Act (Northern Ireland), 1934, made Regulations (hereinafter referred to as "the principal Regulations") on the 27th day of March, 1935, with respect to the compulsory acquisition of land by county councils and sanitary authorities under Section 22 of the said Act:

AND WHEREAS it appears expedient to the Ministry to amend the aforesaid Regulations in manner hereinafter appearing :

NOW, THEREFORE, the Ministry of Home Affairs for Northern Ireland by virtue of the powers vested in it by the Local Government Act (N.I.), 1934, and of every other power in this behalf enabling the Ministry hereby makes and prescribes the following Regulations :—

- 1. These Regulations may be cited as "the Local Authorities (Compulsory Acquisition of Land) Regulations, 1938," and shall be read and construed as one with the principal Regulations;
- 2. Paragraph (c) of sub-article (2) of Article 4 of the principal Regulations shall be deleted and the following paragraph shall be substituted therefor :---
  - "(c) If any of the persons to whom notice of the application is required to be given should be absent from or resides out of the United Kingdom, or cannot be found, the notice may be left with the occupier of the lands, or affixed on some conspicuous part of the lands, proposed to be acquired."

## County Borough Councils : Surveyors

To the Council of each County Borough in Northern Ireland; And to all whom it may concern :

THE MINISTRY OF HOME AFFAIRS FOR NOR-THERN IRELAND (hereinafter referred to as "the Ministry") in exercise of the powers vested in it by Section eighteen of the Local Government Act (Northern Ireland), 1934, and of every other power in that behalf enabling the Ministry, hereby prescribes with respect to the appointment of City Engineers and Surveyors and Assistant City Engineers and Surveyors of County Boroughs in Northern Ireland as follows, that is to say :--

1.—No person shall be qualified to be appointed to the office of City Engineer and Surveyor or Assistant City Engineer and Surveyor of a County Borough Council in Northern Ireland unless :—

- (a) he is a corporate member of the Institution of Civil Engineers:
- (b) he satisfies the Ministry that he has had adequate and suitable experience and has shown capacity in the practice of his profession as a Civil Engineer;
- (c) he produces satisfactory evidence to the Ministry that his health and character are good ;
  - (d) he is a natural-born British subject and is the son of a father also a natural-born British subject;
  - (e) he has during the whole of the period of five years ending on the date of his appointment been resident in the United Kingdom; and
  - (f) he is not at the time of his appointment more than 45 years of age :

Provided that the Ministry may assent to a departure from the provisions of paragraph (f) of this Article in the case of a person holding office under a County Borough Council at the time of his appointment.

- 2.—(a) The provisions of this order shall come into operation on the 1st day of August, 1938.
  - (b) The Ministry may from time to time assent to any departure from the provisions of this order.

3.—This order may be cited as "The County Borough Councils (Surveyors Qualifications) Order, 1938.
