

REGULATIONS, DATED 30TH DAY OF SEPTEMBER, 1939, MADE BY THE
MINISTRY OF AGRICULTURE UNDER SECTION NINE OF THE MILK
AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934.

1939. No. 183.

The Ministry of Agriculture, in exercise of the powers conferred upon it by Section Nine of the Milk and Milk Products Act (Northern Ireland), 1934, and of every other power enabling it in that behalf, hereby makes the following Regulations, that is to say :—

1.—Short Title.

These Regulations shall be known as “ The Milk (Equalisation Payments) Regulations (Northern Ireland), 1939, No. 2.”

2.—Equalisation Payments.

The equalisation payment to be made in respect of all milk produced in Northern Ireland and delivered to (i) creameries and used for the purpose of the extraction of cream for sale as such or for manufacture into butter; (ii) undertakings prescribed by the Ministry of Agriculture and engaged in the manufacture of butter from the milk supplies of several cow-keepers; and (iii) processed milk factories engaged in the manufacture, from the milk supplies of several cow-keepers, of such milk products other than butter and cream as may be prescribed by the Ministry of Agriculture shall in respect of such milk so delivered during the period beginning on the 1st day of October, 1939, and ending on the 31st day of March, 1940, be of such sum as will raise the average price paid by all creameries for such milk to six pence halfpenny per gallon; and shall in respect of such milk so delivered during the period beginning on the 1st day of April, 1940, and ending on the 30th day of September, 1940, be of such sum as will raise the average price paid by all creameries for such milk to five pence per gallon.

The Ministry of Agriculture, in exercise of the powers conferred on it by Section nine of the Milk and Milk Products Act (Northern Ireland), 1934, and of any other powers enabling it in that behalf, hereby makes the following regulations, that is to say:—

(1)—The Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1937(d), amending Articles 17 and 23 of the Milk (Grade A) Regulations (Northern Ireland), 1934(a), are hereby revoked.

(2)—These Regulations may be cited as the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1939, and these Regulations, the Milk (Grade A) Regulations (Northern Ireland), 1934(a), the Milk (Grade A) Regulations (Northern Ireland), 1935(b), the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1936(c), and the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1937(d), and the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1938(e), shall be construed together and may be cited as the Milk (Grade A) (Amended) Regulations (Northern Ireland), 1939.

The Ministry of Agriculture, in exercise of the powers conferred on it by Section nine of the Milk and Milk Products Act (Northern Ireland), 1934, and of any other powers enabling it in that behalf, hereby makes the following regulations, that is to say:—

(1)—The Milk (Grade B) Regulations (Northern Ireland), 1934, (hereinafter referred to as the principal regulations)(a) as amended by subsequent regulations shall have effect as if—
