Juvenile Deposit Contributors.

THE NATIONAL HEALTH INSURANCE (JUVENILE DEPOSIT CONTRIBUTORS) REGULATIONS (NORTHERN IRELAND), 1939, DATED DECEMBER 13, 1939, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1936 AND 1937.

1939. No. 197.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly or separately, in exercise of the powers conferred on them by the National Health Insurance Acts (Northern Ireland), 1936 and 1937, and of all other powers enabling them in that behalf, hereby make the following regulations:—

- 1.—These regulations may be cited as the National Health Insurance (Juvenile Deposit Contributors) Regulations (Northern Ireland), 1939, and shall be deemed to have come into operation on the fourth day of April, 1938.
- 2.—(1) In these regulations, unless the context otherwise requires:—
 - "the Act" means the National Health Insurance Act, 1936, as amended by any subsequent enactment;
 - "the Act of 1937" means the National Health Insurance (Juvenile Contributors and Young Persons) Act, 1937, as extended to Northern Ireland by the National Health Insurance (Juvenile Contributors and Young Persons) Act (Northern Ireland), 1937, and the National Health Insurance (Extension of Enactments) Order (Northern Ireland), 1938;
 - "the Ministry" means the Ministry of Labour for Northern Ireland;
 - "employment" means employment within the meaning of the Act;

- "proper proportion" in relation to the cost of the medical benefit of juvenile deposit contributors and of the administration of that benefit means the proportion of the cost of medical benefit and of administration payable out of contributions paid by or in respect of juvenile deposit contributors;
 - " society " means an approved society.
- (2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 3.—For the purposes of paragraph (a) of subsection (3) of section 3 of the Act of 1937, the following provisions shall apply:—
 - (1) The sum to be payable in respect of the cost of medical benefit to juvenile deposit contributors shall be at the yearly rate of twelve shillings in respect of each of the total number of juvenile deposit contributors.
 - (2) The sum to be payable in respect of expenses incurred by the Ministry in connection with the administration of medical benefit to juvenile deposit contributors shall be at the yearly rate of sixpence in respect of each of the total number of juvenile deposit contributors.
 - (3) The total number of juvenile deposit contributors for the purposes of paragraphs (1) and (2) of this regulation shall be determined in such manner as the Ministry thinks fit.
- 4.—The proper proportion of the yearly sums required under regulation 3 for the purpose of meeting the cost of medical benefit to juvenile deposit contributors and of the expenses of the Ministry in connection with the administration of that benefit shall be payable out of the Juvenile Deposit Contributors Fund:

Provided that in the case of juvenile deposit contributors by or in respect of whom reduced contributions have been paid in the course of any year as being employed as seamen in foreign-going ships, the amount payable under this regulation in the year shall be reduced by the proper proportion of the sum of two pence for every such reduced contribution.

- 5.—The expenses incurred by the Ministry in respect of the administration of the Juvenile Deposit Contributors Fund shall, to the extent determined by the Ministry, be charged in each year against the Fund, and the amount so charged shall be paid to the Ministry towards the expenses incurred by it.
- 6.—There shall from time to time be carried to the credit of the Reserve Suspense Fund so much of any sum standing to the credit of the Juvenile Deposit Contributors Fund as is not required for the purposes of that Fund, and there shall be credited out of the

Reserve Suspense Fund to the Juvenile Deposit Contributors Fund any sum required at any time to make good a deficiency in that Fund.

- 7.—A juvenile deposit contributor who joins a society shall be deemed to have become a member of the society at the commencement of the contribution half-year in which he is admitted to membership of the society or at such other date as the Ministry, having regard to the special circumstances of any case, may determine.
- 8.—(1) A juvenile deposit contributor shall give notice to the Ministry of any change of his address.
- (2) A juvenile deposit contributor shall furnish such information as the Ministry may require for the purpose of being satisfied as to his age, employment and otherwise as to his title to benefit.
