SCHEDULE.

In pursuance of Article 18 (e) of the Reserve and Auxiliary Forces (Consequential Provisions) Order, dated 23rd day of June, 1939, made under Section 4 of the Reserve and Auxiliary Forces Act, 1939, and of Sections 70 and 71 of the Education Act (Northern Ireland), 1923, the Ministry of Finance, in consultation with the Ministry of Education, hereby frames the following Teachers' Superannuation (Service in the Reserve and Auxiliary Forces) Scheme.

- 1.—This Scheme may be cited as the Teachers' Superannuation (Service in the Reserve and Auxiliary Forces) Scheme, 1939.
- 2.—The Interpretation Act, 1921, shall apply to the interpretation of this Scheme as it applies to the interpretation of an Act of Parliament.
- 3.—Where a person called out is a teacher within the meaning of any Scheme (hereinafter referred to as the "relevant Superannuation Scheme") framed under Sections 70 and 71 of the Education Act (Northern Ireland), 1923, or under that Act as amended by the Teachers' Superannuation Act (Northern Ireland), 1926, he shall be deemed to be employed in service within the meaning of the relevant Superannuation Scheme during the period of his service as a person called out his service as a person called out.
- 4.—Teachers' and (where applicable) school contributions shall be payable by or in respect of him during the period of his service as a person called out provided that the teacher continues to receive from the Ministry, local authority, managing authority or other body by whom he was employed, the whole or part of the salary received by him before being called out.
- 5.—For the purposes of the relevant superannuation scheme a teacher shall be deemed to be in receipt, during the period of his services as a person called out, of a salary of such annual amount as in the opinion of the Ministry he would have received if he had been employed during the said period in service as a teacher.
- 6.—In this Scheme the following expressions have the meaning hereby

- o.—in this scheme the ionowing expressions have the meaning hereby respectively assigned to them:—
 "the Ministry" means "the Ministry of Education";
 "local authority" or "managing authority" has the same meaning as in Section 10 of the Teachers' Superannuation Act (Northern Ireland), 1926;
 - "called out" has the same meaning as in the Reserve and Auxiliary Forces (Consequential Provisions) Order, 1939.

 - (ii) for the specifications for flats and pads set out in Part III of the Second Schedule there were substituted the specifications set out in Part II of the Schedule to these Rules.
 - 2.—(1) These Rules may be cited as the Marketing of Eggs Rules (Northern Ireland), 1939.

Citation, construction and commencement.

- (2) These Rules shall be construed as one with the Marketing of Eggs Rules (Northern Ireland), 1938, and the Marketing of Eggs (Amendment) Rules (Northern Ireland), 1938(b), and those Rules and these Rules may be cited together as the Marketing of Eggs Rules (Northern Ireland), 1938 to 1939.
- (3) These Rules shall come into operation on the first day of April, 1939.


No. 3 STANDARD CASE.

This case is designed for 3 hd. (360) hen eggs of the "Selected" or "Standard" grades.

DESCRIPTION.

The case shall be made in two equal compartments and in accordance with the following specification:—

ENDS.

Each end shall consist of three boards fixed upright, one of which shall be placed exactly in the middle of the end, and shall be not less than 5 inches wide. To the end boards shall be nailed cross battens measuring not less than 123 inches by 2 inches by 16 inch thick, two on each end, fixed externally, one across the bottoms of the end boards and the other as close to the tops of the end boards as the construction of the lid permits. The ends of the battens shall be flush with the outer sides of the side boards.

CENTRE DIVISION.

The division shall consist of one or two boards which shall be fixed in the centre of the case secured by nails driven through the side and bottom boards.

SPACING.

The spacing between any two adjoining boards throughout the case shall nowhere exceed a inch, except between the centre division boards. In constructing the tops and bottoms of cases two boards may be used

instead of three provided that the spacing does not exceed § inch.

When spacing is provided between any two side boards, it shall be so arranged as to prevent any of the flats working through.

FILLERS AND FLATS.

Fillers shall be 2½ inches in depth, each division being 1¾ inches square and the extreme width of the filler 11¼ inches.

Flats shall be 114 inches square,

NAILS AND NAILING.

Not less than two nails shall be used in each end of each board including the cross battens, and an additional nail shall be used at each end of a board, for every 3 inches or part of 3 inches by which the board exceeds 5 inches in width.

The nails shall be not less than 1½ inches of 14 gauge, and shall be cement-coated. The nails shall be driven askew the grain of the wood.

No. 3 STANDARD CASE (LARGE).

This case is designed for 3 hd. (360) hen eggs of the "Special" or "Extra Special" grades or duck eggs.

The specification for this case shall, subject to the modifications set forth below, be similar to that for the No. 3 Standard case.

FILLERS AND FLATS.

Fillers shall be $2\frac{1}{4}$ inches in depth, each division being $1\frac{1}{4}$ inches square, and the extreme width of the filler shall be $12\frac{1}{4}$ inches.

Flats shall be 121 inches square.

PART II.

FLATS.

Flats shall be of the corrugated type, or such other type as may be approved by the Ministry. A corrugated flat shall be placed between each pair of fillers with the corrugated side uppermost.

The specification for flats shall be as follows:-

(a) Material:

The fibrous constituents of the flat shall be mechanical or chemical wood pulp or a combination of both (not excluding waste paper of suitable quality), so treated as to comply in other respects with this specification.

(b) Weight:

The paper shall be of substance equivalent to 130 grammes per square metre.

(c) Bursting Strain:

The bursting strain of the paper when tested by the Mullen Paper Tester shall be not less than one-sixth of the appropriate weight specified in paragraph (b) above, expressed in lbs. per square inch.

- (d) Bulk: .0074.
- (e) Colour:
- (f) Flutes:

 Per foor 32. The flutes shall be regular in shape throughout the length of the flat and shall not be cut or dented,

- (g) Height of Flutes: 3/16"
- (h) Mineral Matter: The ash shall not exceed 10% on complete incineration.
- (i) Water Absorption: There shall not be any penetration of water through to the top side when representative samples measuring $\frac{1}{2}$ inch x inch are floated on the surface of distilled water in a glass vessel, at $60/65^{\circ}$ Fahrenheit, for 10 minutes.
- (j) Adhesive: Any reliable adhesive free from nitrogenous matter.

Pads shall consist of two flats as specified in these Rules in the bottom of each compartment of a case and one flat at the top of each compartment of a case. The flats used in the bottom of the case shall be placed together with the flutes running in opposite directions and with the corrugations turned upwards. The flats at the top of the case shall have their corrugations turned downwards.

- (2) These Rules shall be construed as one with the Marketing of Eggs Rules (Northern Ireland), 1938(a) (hereinafter called the Principal Rules); the Marketing of Eggs (Amendment) Rules (Northern Ireland), 1938(b); and the Marketing of Eggs Rules (Northern Ireland), 1939(c); and shall be included among the Rules which may be cited together as the Marketing of Eggs Rules (Northern Ireland), 1938 to 1939.

PART II.

Weekly Return.

2.—A licensed wholesale dealer of Class A shall complete and furnish to the Ministry in respect of each week a return in form No. 1 prescribed in the Schedule to these Rules of his purchases of ungraded eggs. The return shall be sent to the Ministry so as to
