Police Service: Form of Declaration.

WARRANT, DATED STH MARCH, 1939, MADE BY THE MINISTRY OF FINANCE FOR PRESCRIBING FORMS OF DECLARATION TO BE SUBSCRIBED BY POLICE PENSIONERS AND LIST OF PERSONS ENTITLED TO ATTEST SUCH DECLARATIONS.

1939. No. 33.

WHEREAS it is enacted by sub-section (1) of Section 4 of the Appropriation Act (Northern Ireland), 1938, as follows:—"A person shall not receive any payment out of a grant which may be made in pursuance of this Act for civil or police non-effective services, until he has subscribed such declaration as may from time to time be prescribed by a warrant of the Ministry of Finance before one of the persons prescribed by the warrant:

Provided that the Ministry of Finance may dispense with the production of a declaration under this section in respect of any payment if such a declaration has been subscribed within a period of twelve calendar months preceding the date of the payment, or such longer period as the said Ministry may in any particular case allow."

AND WHEREAS it is expedient that this warrant should apply in relation to any provision as to payments for police non-effective services to the like effect as the enactment hereinbefore recited which may be made by Parliament in any future Session, when appropriating the supplies granted in such Session :

Now, THEREFORE, the Ministry of Finance, by virtue of the powers given to it by the enactment hereinbefore recited and all other powers enabling it in this behalf, and as well for the purposes of the enactment hereinbefore recited as for the purposes of any other such

provision which may be made as aforesaid, hereby prescribes as follows in respect of persons claiming to receive payment out of grants for police non-effective services, that is to say :---

1.—The expression "The Force" means either the Royal Ulster Constabulary or the Special Constabulary as the case may be.

2.—The declaration shall contain a statement—

- (a) in the case of a pension, that the declarant has been granted the pension, and
- (b) in the case of an allowance, that the declarant is the mother or guardian, as the case may be, of the child or children to whom the allowance has been granted,

and in any such case the declaration shall include such additional statements as are hereafter in this Warrant prescribed in that behalf.

3.—(a) In the case of a pension of a former member of the Force the declaration shall state :—

(i) his usual place of residence at the time of making the declaration;

- (ii) the annual amount of the pension;
- (iii) that he is the person entitled to receive the pension;
- (iv) that, excepting service in respect of which the pension has been granted, he has not during any part of the preceding twelve months served in any Police Force; and
- (v) particulars of all monies other than the pension which have been received by him during the preceding twelve months and which have been paid out of monies provided by any Parliament within the British Isles with particulars of the service or employment in respect of which they have been paid.

(b) In the case of the pension of the widow of a former member of the Force the declaration shall state :---

(i) her usual place of residence at the time of making the declaration :

(ii) the annual amount of the pension;

(iii) that she is the widow of that former member of that. Force and the person entitled to receive the pension;

- (iv) that she has not re-married since the death of that member; and
- (c) In the case of an allowance to the child of a former member of the Force the declaration shall state :---
 - (i) the full name of the child and that it is the child of that member of the Force and is the child to whom the allowance has been granted;
 - (ii) the usual place of residence of the child at the time of making the declaration;
 - (iii) the date of birth of the child;
 - (iv) that the child is living at the time of making the declaration and is under the care of and being maintained by the declarant;
 - (v) the usual place of residence of the declarant at the time of making the declaration;
 - (vi) that the declarant is the person entitled to receive the allowance on behalf of the child;
 - (vii) the annual amount of the allowance or, where the allowances granted to several children of the same former member of the Force are payable to one person and are included in one declaration, the aggregate annual amount of such allowances.

4.—The person making the declaration shall subscribe it before one of the persons described in the Schedule to this Warrant (in this Warrant referred to as the "attestor"), and the attestor shall state fully the qualification which entitles him to attest, shall certify that the declaration was made in his presence, and shall certify whether he believes the person making the declaration to be the grantee named in the declaration : Provided that the person before whom a declaration shall be subscribed shall not be the person to whom or on whose behalf payment is to be made in accordance with the said declaration.

In cases where a declaration in respect of a pension is signed by a person other than the grantee, one of the persons described in the Schedule to this Warrant shall certify when he last saw the grantee alive.

5.—Nothing in this Warrant shall prevent the Ministry of Finance, if it sees fit, from requiring a declaration to be subscribed before some person, being one of the persons included in the Schedule, whom the said Ministry may select for the purpose.

6.—From and after the date of this Warrant, unless in any particular case the Ministry of Finance otherwise determines, a declaration shall not be required in respect of a payment to which this Warrant applies if such a declaration has been subscribed within a period of twelve calendar months preceding the date of the payment.

SCHEDULE.

Persons before whom the Declarations may be subscribed:

In the United Kingdom or any other part of the British Empire :--

Magistrates or Justices of the Peace.

Commissioners for Oaths.

- Ministers of Religion habitually officiating at a place of worship within 10 miles of the place where the pensioner resides for the time being. (The denomination and the address of the place of worship must be given.)
- Physicians or Surgeons registered as such under the law of the country, and regularly practising within 10 miles of the place where the pensioner resides for the time being.
- Officials of Banks registered under the law of the country, namely, Managers, Secretaries, Chief Cashiers, Accountants, Officials for the time being in charge of branch Banks, and other officials authorised by the Banks to sign documents on their behalf. (The qualification of the official and the name of the Bank or branch Bank must be given.)
- Officials of Savings Banks registered under Act of Parliament, namely, Actuaries, Managers, Directors, Secretaries, Chief Cashiers, Accountants and officials for the time being in charge of branch Banks. (The qualification of the official and the name of the Bank or branch Bank must be given.)
- Commissioned Officers of Police and Police Officers in actual charge of the nearest Police Station to the place where the pensioner resides for the time being.

In any part of the World :--

Officers of His Majesty's Naval, Military or Air Forces on the Active or half-pay or pensions lists.

In the United Kingdom only:-Persons on the Active or Pension List of the permanent Civil Service of the Crown (including the permanent Civil Service of Northern Ireland) who are, or were, at the date of retirement, on a scale of salary com-mencing at \$400 a year or over.

TRADE BOARDS

Head Teachers of Public Elementary and Secondary Schools. (The name of the school is to be given on the form of attestation.)

British Diplomatic or Consular Officers empowered by law to administer Oaths.

Notaries Public or other persons competent by the law of the country to administer such declarations. (The law must be quoted sufficiently for verification.)

Ministers of Religion duly licensed by Ecclesiastical Authority in Great Britain to officiate as Chaplains in the places where they attest.

REGULATIONS, DATED THE 22ND DECEMBER, 1939, AMENDING REGULATIONS MADE BY THE MINISTRY OF LABOUR UNDER SECTION 17 OF THE TRADE BOARDS ACT (NORTHERN IRELAND), 1923, (13 AND 14 GEO. 5, CH. 32), WITH RESPECT TO THE CONSTITUTION, PROCEEDINGS AND MEETINGS OF TRADE BOARDS.

The Ministry of Labour (hereinafter referred to as "the Ministry"), in pursuance of powers conferred by the Trade Boards Act (Northern Ireland), 1923, as amended by Section 2 of the Trade Boards Act (Northern Ireland), 1939, and of every other power the Ministry hereunto enabling, hereby makes the following Regulations :—

The following Regulation shall be substituted for Regulation
(a) of each of the Regulations specified in the Schedule :--

"2.—(a) Either one appointed member, or three appointed members, as the Ministry may think fit;"

2. The following Regulation shall be substituted for Regulation 3 of each of the Regulations specified in the Schedule :---

"3.—Appointed members shall be independent persons appointed by the Ministry. The Chairman of the Trade Board shall be the appointed member designated by the Ministry to act as Chairman."
