REGULATIONS, DATED 16TH AUGUST, 1940, MADE BY THE MINISTRY OF LABOUR UNDER THE UNEMPLOYMENT INSURANCE (EMERGENCY POWERS) ACT (NORTHERN IRELAND), 1939.

## 1940. No. 107.

Whereas the Ministry of Labour for Northern Ireland has made the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939 (hereinafter referred to as the "principal Regulations"), and the said Regulations have been amended and it is desirable further to amend the said Regulations;

Now, therefore, the Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by the Unemployment Insurance (Emergency Powers) Act (Northern Ireland), 1939, and of all other powers in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations:—

Short title and commencement.

- 1.—(1) These Regulations may be cited as the Unemployment Insurance (Emergency Powers) (Amendment) Regulations (No. 5) (Northern Ireland), 1940, and shall come into force on the date hereof, and these Regulations shall be included among the Regulations which may be cited together as the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939 and 1940.
- (2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

Interpretation

- 2. In regulation 2 of the principal Regulations (which contains certain definitions) after the definition of "the 1939 Act" there shall be inserted the following definition:—
  - "" the 1940 Act" means the Unemployment Insurance Act (Northern Ireland), 1940;

Amendment of regulation 3 of the principal Regulations.

- 3. At the end of regulation 3 of the principal Regulations there shall be inserted the following proviso:—
  - " Provided that at any time the Minister may-
    - (a) permit the holder of any existing certificate to identify any person employed in an employment to which the certificate relates if such person—

(i) is employed in employment which is insurable employment by virtue of the provisions of section 4 of the 1940 Act; and

(ii) was duly identified under the certificate before 29th September, 1939, or could have been so identified before that date if the provisions of the said section 4 had then been in force; and

(b) give to any past or present holder of a certificate a new certificate relating to any employment to which the provisions of Part III of the said Schedule apply so, however, that any such certificate shall relate only to persons whose employment is insurable employment by virtue of the provisions of the said section 4 and who, before 29th September, 1939, had completed three years' continuous service in an employment to which the certificate relates."
