

(3) Articles not produced on the Farm : Articles not produced on the farm but provided by an employer in part payment of wages shall be valued at the average price currently paid by employers for such articles in the district as determined from time to time by the Board.

(4) Keep of Animals : In fixing for a district a general value or values for such a benefit as the keep or keep and use of livestock provided by the employer in part payment of wages, the Board shall have regard to the normal cost to the employer of providing such benefit.

4.—Any questions as to the construction or the interpretation of these Regulations may, for the purposes of any meeting of the Board, be decided by the Chairman or other person presiding but any member may require it to be referred to the Ministry for future guidance.

Casual Vacancies.

THE AGRICULTURAL WAGES BOARD (CASUAL VACANCIES) REGULATIONS (NORTHERN IRELAND), 1940, DATED THE 8TH DAY OF OCTOBER, 1940, MADE BY THE MINISTER OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION ONE OF THE AGRICULTURAL WAGES (REGULATION) ACT (NORTHERN IRELAND), 1939. (2 AND 3 GEORGE VI, CHAPTER 25.)

Whereas in pursuance of section one of the Agricultural Wages (Regulation) Act (Northern Ireland), 1939, the Minister of Agriculture made regulations (hereinafter referred to as "the principal Regulations") for determining the term and conditions of office of the persons appointed as members of the Board as defined in the principal Regulations :

And whereas it is expedient to make further provision for determining the said matters and for determining the manner of appointing members to fill casual vacancies in the said Board :

Now, therefore, I, the Right Honourable Sir Basil Stanlake Brooke, Bart., Minister of Agriculture for Northern Ireland, hereby make the following Regulations determining the matters aforesaid :—

1.—The principal Regulations shall have effect as if after Regulation 3 thereof the following Regulation were inserted :—

“ **3A.**—(1) A casual vacancy shall be deemed to have arisen in the Board when a member thereof has died or become incapable of acting as such member, or has ceased to hold office for any cause specified in Regulation 3 hereof.

(2) A casual vacancy shall be filled—

(a) in the case of a member appointed by the Minister of Agriculture, by the appointment of a member by that Minister, and

(b) in the case of a member appointed by a prescribed organisation, by the appointment of a member by that organisation.

2.—These Regulations may be cited as the Agricultural Wages Board (Casual Vacancies) Regulations (Northern Ireland), 1940.

Minimum Rates of Wages.

THE AGRICULTURAL WAGES (NOTICE OF THE FIXING, CANCELLING, OR VARYING OF MINIMUM RATES OF WAGES) REGULATIONS (NORTHERN IRELAND), 1940, DATED THE 29TH DAY OF APRIL, 1940, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER SECTION SIX OF THE AGRICULTURAL WAGES (REGULATION) ACT (NORTHERN IRELAND), 1939. (2 AND 3 GEORGE VI, CHAPTER 25.)

The Ministry of Agriculture for Northern Ireland, in exercise of the powers conferred on it by Section Six of the Agricultural Wages (Regulation) Act, 1939, and of every other power enabling it in that behalf, hereby makes the following regulations, that is to say :—

PART I.

Short Title and Interpretation.

1.—These Regulations may be cited as the Agricultural Wages (Notice of the fixing, cancelling or varying of Minimum Rates of Wages) Regulations (Northern Ireland), 1940.
