The Ministry of Finance for Northern Ireland, in exercise of the powers conferred upon it by Section 45 of the Unemployment Act (Northern Ireland), 1934 (as applied by Section 10 of and Second Schedule to the Old Age and Widows' Pensions Act (Northern Ireland), 1940) and by Section 4 of the Workmen's Compensation (Supplementary Allowances) Act (Northern Ireland), 1940, hereby makes the following Regulations:—

- 1.—The requisition to be made to entitle any person to obtain a certified copy of an entry of birth required for the purposes of—
 - (a) Part II of the Old Age and Widows' Pensions Act (Northern Ireland), 1940; or
- (b) the Workmen's Compensation (Supplementary Allowances)
 Act (Northern Ireland), 1940;
 shall be in the Form A set out in the Schedule to these Regulations.
- 2.—The requisition to be made to entitle any person to obtain a certified copy of an entry of death required for the purposes of the Old Age and Widows' Pensions Act (Northern Ireland), 1940, shall be in the Form B set out in the Schedule to these Regulations.
- 3.—The requisition to be made to entitle any person to obtain a certified copy of an entry of marriage required for the purposes of—
 - (a) Part II of the Old Age and Widows' Pensions Act (Northern Ireland), 1940; or
- (b) the Workmen's Compensation (Supplementary Allowances)
 Act (Northern Ireland), 1940;
 shall be in the Form C set out in the Schedule to these Regulations.
- 4.—These Regulations may be cited as the Certificates of Births, Deaths and Marriages (Requisition) Regulations (Northern Ireland), 1940.

Rules, dated 17th June, 1940, made by the Ministry of Commerce under the Building Societies Act (Northern Ireland), 1940.

1940. No. 50.

The Ministry of Commerce, in exercise of the powers conferred on it by the Building Societies Act (Northern Ireland), 1940, hereby makes the following Rules:—

- 1.—The notices and the returns required or authorised to be prescribed for the purposes of the said Act shall be in such form and shall contain such particulars as are set out in the schedule hereto.—
- 2.—A notice in Form 1, Form 2 or Form 3 shall be deemed not to have been validly given unless, before the contract to which it relates was made, the person to whom the notice was given signed a duplicate thereof and delivered it to the person by whom, or on whose behalf, the notice was given. The words "Received a notice of which the foregoing is a copy" shall be appended to the duplicate, together with the signature of the recipient and the date,
