

- (b) give to any past or present holder of a certificate a new certificate relating to any employment to which the provisions of Part III of the said Schedule apply so, however, that any such certificate shall relate only to persons whose employment is insurable employment by virtue of the provisions of the said section 4 and who, before 29th September, 1939, had completed three years' continuous service in an employment to which the certificate relates."

REGULATIONS, DATED 31ST DECEMBER, 1940, MADE BY THE MINISTRY OF LABOUR UNDER THE UNEMPLOYMENT INSURANCE (EMERGENCY POWERS) ACT (NORTHERN IRELAND), 1939.

1940. No. 169.

Whereas the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") has made the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939 (hereinafter referred to as "the principal Regulations"), and the said Regulations have been amended and it is desirable further to amend the said Regulations;

Now, therefore, the Ministry, by virtue of the powers conferred on it by the Unemployment Insurance (Emergency Powers) Act (Northern Ireland), 1939, and of all other powers in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Emergency Powers) (Amendment) Regulations (No. 6) (Northern Ireland), 1940, and shall come into force on the date

hereof and shall be included among the Regulations which may be cited together as the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939 and 1940.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—After Regulation 22 of the principal Regulations there shall be inserted the following Regulations :—

“ 23.—(1) During the operation of these Regulations an insured contributor who is attending at a training course provided by the Ministry or at a training course or course of instruction provided in pursuance of arrangements made with the Ministry by any public authority, firm or person, and in respect of whose attendance at any of the said courses the payment of training allowances is made by or on behalf of the Ministry to the said contributor, shall be deemed to be not available for work whilst he is so attending; and accordingly section 24 of the Act (which deals with the third statutory condition for the receipt of benefit) shall have effect in relation to any such contributor as if sub-section (2) were omitted.

(2) Time during which an insured contributor is deemed to be not available for work by reason of the foregoing provisions of this Regulation shall not be excluded in the computation of continuous periods of unemployment, and accordingly sub-section (3) of section 36 of the Act (which provides for the exclusion of certain time in the computation of continuous periods of unemployment) shall, as respects any such time, have effect as if the reference in the said sub-section to the third statutory condition were omitted.

24.—During the operation of these Regulations :—

(a) section 84 of the Act (which deals with the power to make grants out of the Unemployed Fund towards expenses of attendance at authorised courses) shall have effect as if in sub-section (1) thereof the words ‘ in receipt of benefit ’ were omitted and section 9 of the 1939 Act (which contains amendments as respects training courses) shall have effect as if the provisions of sub-section (2) were omitted; and

(b) grants payable out of the Unemployment Fund under the said section 84 in respect of attendance at authorised courses being training courses shall be

such amounts as the Ministry with the consent of the Ministry of Finance for Northern Ireland may determine instead of the grants provided by paragraph (b) of sub-section (2) of that section.

25.—(1) During the operation of these regulations the provisions of section 110 of the Act (which deals with payment out of the Unemployment Fund of travelling expenses of insured contributors) shall have effect as if in sub-section (1) thereof instead of the power of the Ministry to make repayment as provided by that sub-section and the Regulations made thereunder there were substituted a power for the Ministry to repay out of the Unemployment Fund to the Exchequer of Northern Ireland such sums as it may with the consent of the Ministry of Finance for Northern Ireland from time to time determine.

(2) Where repayment has been made out of the Unemployment Fund to the Exchequer of Northern Ireland under the power conferred by paragraph (1) of this Regulation the sum which under sub-section (2) of the said section 110 may be recovered or deducted shall be the sum which could have been repaid under that section if this Regulation had not been made.”
