Residence Condition.

REGULATIONS, DATED 22ND JULY, 1940, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 26 OF THE UNEMPLOYMENT INSURANCE ACT (NORTHERN IRELAND), 1936.

1940. No. 88.

The Ministry of Labour for Northern Ireland, by virtue of the powers conferred on it by Section 26 of the Unemployment Insurance Act (Northern Ireland), 1936, and of all other powers in that behalf, hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Residence Condition) Regulations (Northern Ireland), 1940, and shall come into force on the date hereof.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—In determining whether an insured contributor has fulfilled the fifth statutory condition, no account shall be taken of residence outside the United Kingdom for any cause for a period not exceeding five years, or for periods which in the aggregate do not exceed five years, or for such longer period or periods as may be due to :—

- (a) Employment in the Naval, Military or Air Service of the Crown ;
- (b) Employment which is insurable employment under the Unemployment Insurance Acts as in force in Great Britain or Northern Ireland ;
- (c) Any other cause which, in the opinion of the Minister of Labour, was in all the circumstances reasonable :

Provided that in the case of an insured contributor who does not fulfil the fifth statutory condition as modified by the foregoing

provisions of these Regulations and who was during the five years immediately preceding the date on which application for benefit is made, or during any part or parts thereof, employed outside the United Kingdom in the Naval, Military or Air Service of the Crown then and in such case instead of the period of five years for which under the fifth statutory condition an insured contributor is required to show residence in the United Kingdom, such insured contributor shall be required to show that he has been so resident only for such part or parts (if any) of the said period of five years as he was not so employed as aforesaid.

3.—The Unemployment Insurance (Residence Condition) Regulations (Northern Ireland), 1928, are hereby revoked, but without prejudice to anything duly done or suffered, or to any right, privilege, obligation or liability acquired, accrued or incurred, thereunder.

THE UNEMPLOYMENT INSURANCE (SUBSIDIARY EMPLOYMENTS) REGULATIONS (NORTHERN IRELAND), 1940, DATED DECEMBER 31, 1940, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE UNEMPLOYMENT INSURANCE ACTS (NORTHERN IRELAND), 1936 TO 1940.

The Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry"), in exercise of the powers conferred by paragraph 10 of Part II of the First Schedule to and Section 3 (7) of the Unemployment Insurance Act (Northern Ireland), 1936, and by Section 14 of the Unemployment Insurance Act (Northern Ireland), 1939, and of all other powers enabling it in that behalf, and with the consent of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations:—

1.—(1) These Regulations may be cited as the Unemployment Insurance (Subsidiary Employments) Regulations (Northern Ireland), 1940.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
