## Emergency Regulations

- (c) the words "the 'quarter date' next succeeding" shall be omitted from paragraph 4 of the form set out in Part II of the Schedule; and
- (d) the footnote shall be omitted from the form set out in Part II of the Schedule.

**3.**—(1) These Regulations shall not affect any persons who have ceased to receive whole-time education before the first day of September, 1939.

(2) Nothing contained in these Regulations shall affect the operation of Regulation 13 of the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939.

#### **Emergency Regulations.**

REGULATIONS, DATED 12TH JANUARY, 1940, MADE BY THE MINISTRY OF LABOUR UNDER THE UNEMPLOYMENT INSURANCE (EMERGENCY POWERS) ACT (NORTHERN IRELAND), 1939.

### 1940. No. 9

Whereas the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") has made the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland). 1939 ((hereinafter referred to as "the principal Regulations") and it is desirable to amend the said Regulations;

Now, therefore, the Ministry, by virtue of the powers conferred on it by the Unemployment Insurance (Emergency Powers) Act (Northern Ireland), 1939, and of all other powers in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby makes the following Regulations :--

#### UNEMPLOYMENT INSURANCE

Short Title and commencement 236

1.---(1) These Regulations may be cited as the Unemployment Insurance (Emergency Powers) (Amendment) Regulations (Northern Ireland), 1940, and shall come into force on the date hereof, and these Regulations shall be included among the Regulations that may be cited together as the Unemployment Insurance (Emergency Powers) Regulations (Northern Ireland), 1939 and 1940.

(2) The Interpretation Act, 1921, applies to the interpretation of these Regulations as it applies to the interpretation of an Act of Parliament.

Interpretation 2.—At the end of paragraph (1) of Regulation 2 of the principal Regulations (which contains certain definitions) there shall be added the following definitions :—

- "the 1938 Act" means the Unemployment Insurance Act (Northern Ireland), 1938;
- "the 1939 Act" means the Unemployment Insurance Act (Northern Ireland), 1939.

Amendment **3.**—At the end of Regulation 6 of the principal Regulations there of Regulation shall be inserted the following :—

" Provided that this Regulation shall not apply—

- (1) to cases in which employers' contributions only have been paid in respect of persons who have attained the age of sixty-five years, and
- (2) to any case in which—
  - (i) an application was duly made under the said provisions on or before 29th September, 1939, and
  - (ii) the Ministry is satisfied that there are sufficient departmental records available and sufficient evidence therein to enable it to determine the amount of the repayment that ought properly to be made under the said provisions."

Amendment **4.**—At the end of Regulation 10 of the principal Regulations of Regulation there shall be inserted the following :—

> " and accordingly references in section 28, sub-section (1) of section 29 and sub-section (2) of section 50 of the Act to the Court of Referees shall be construed as including references to the Insurance Officer."

5.—After Regulation 17 of the principal Regulations there shall be added the following Regulations :—

" 18.—During the operation of these Regulations paragraph 4 Auxiliary of Part II of the First Schedule to the Act (which excepts from Services. insurance under the Act employment as a female professional nurse for the sick or as a female probationer undergoing training for employment as such a nurse) shall have effect as if at the end thereof there were added the words-

#### ' except

- (a) employment as a nursing auxiliary in the civil nursing reserve; and
- (b) employment as a nursing auxiliary and similar employment of a nursing character in connection with the civil defence service under a scheme made under sub-section (1) of section 1 of the Air Raid . Precautions Act (Northern Ireland), 1938, or under sub-section (3) of section 35 of the Civil Defence Act (Northern Ireland), 1939.'

**19.**—During the operation of these Regulations the provisions  $W_{\text{er}}$ of paragraph (c) of sub-section (3) of section 3 of the Act and occupations outsideUnited of the Unemployment Insurance (Employment Outside the Kingdom-United Kingdom) Regulations (Northern Ireland), 1939, shall have effect as if references therein to employment outside the United Kingdom for the purpose of the execution of some particular work included references to employment outside the United Kingdom in any war occupation specified in the Schedule hereto (being employment which began on or after 1st September, 1939) and, in the application of the said provisions to such last-mentioned employment, as if proviso (d) to Regulation 3 of the Unemployment Insurance (Employment Outside the United Kingdom) Regulations (Northern Ireland), 1939, and the requirement that persons employed therein must, immediately before leaving Northern Ireland, have been insured contributors, were omitted.

20.—The operation of sub-sections (1) and (6) of section 1 Holidays and of the 1939 Act (which relates to holidays) and of any continuous Regulations made under sub-sections (1) to (6) of that section unemploy. and of section 3 of the 1939 Act (which relates to continuous ment. periods of unemployment) shall be suspended during the operation of these Regulations, and accordingly-

- (a) for sub-section (7) of the said section 1 there shall be substituted the following sub-section :---

(7) Sub-sections (1) and (6) of this section and any Regulations made under the foregoing provisions of this section shall not come into operation until such day as the Ministry may by order appoint.'

(b) for sub-section (3) of the said section 3 there shall be substituted the following sub-section :---

(3) This section shall come into operation on such day as the Minstry may by order appoint."

6.—The following Schedule shall be added at the end of the principal Regulations :—

#### SCHEDULE.

War occupations outside the United Kingdom which are to be insurable employments.

- (1) Employment in a civilian capacity by the Admiralty, Army Council, Air Council or other Government Department;
- (2) Employment by a Works Contractor to the Admiralty, Army Council or Air Council ;
- (3) Employment by the Navy, Army and Air Force Institutes;
- (4) Employment by a voluntary organisation engaged in hospital, ambulance or canteen work.
