

Inspector or other officer of the Local Authority has certified that the sheep were double dipped as specified in Article 1 of this Order in his presence during such period.

Offences.

4.—Any person committing or aiding, abetting or counselling or procuring the commission of any breach of the provisions of this Order is liable on summary conviction to the penalties provided by the Diseases of Animals Acts, 1894 to 1935.

Interpretation.

5.—In this Order :

“ Sheep ” includes lambs.

Short Title.

6.—This Order may be cited as the Sheep Dipping (Special Regulation) (Northern Ireland) Order of 1941.

Commencement.

7.—This Order shall come into operation on the date hereof.

Swine Fever.

ORDER, DATED THE 14TH DAY OF JANUARY, 1941, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE DISEASES OF ANIMALS ACTS, 1894 TO 1935.

1941. No. 12.

The Ministry of Agriculture for Northern Ireland by virtue and in exercise of the powers vested in it under the Diseases of Animals Acts, 1894 to 1935, as amended and adapted by any subsequent enactments, and of every other power enabling it in that behalf, orders and it is hereby ordered as follows :—

Sale of Swine in Belfast.

1.—Notwithstanding the provisions of the Swine Fever (Belfast) Order, 1936, the Royal Ulster Agricultural Society is hereby permitted to hold its Spring Show and Sale of Swine on the 26th February, 1941, in the Saleyard, the property of Messrs. John Robson, Ltd., Stewart Street, Belfast.

Short Title.

2.—This Order may be cited as the Swine Fever (Emergency Sale) Order, 1941.

Commencement.

3.—This Order shall come into operation on the date hereof.

THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND, BY VIRTUE
AND IN EXERCISE OF THE POWERS VESTED IN IT UNDER THE DISEASES
OF ANIMALS ACT, 1894, AS AMENDED AND ADAPTED BY ANY SUBSE-
QUENT ENACTMENTS AND OF EVERY OTHER POWER ENABLING IT IN
THAT BEHALF, ORDERS AND IT IS HEREBY ORDERED AS FOLLOWS :—

Interpretation.

1.—In this Order—

“The Ministry” means the Ministry of Agriculture for Northern
Ireland ;

“Animals” means cattle, sheep, goats, all other ruminating
animals and swine ;

“Person” includes a body corporate or unincorporate.

Records of Movements of Stock.

2.—The owner or the person using or the person in charge of any
mechanically propelled vehicle used on a road or lane for the conveyance
of animals shall keep a true record in the form prescribed in the
Schedule hereto or to the like effect, in which shall be entered all the
prescribed particulars of the movement of animals by the said vehicle :

Provided that a record shall not be required to be kept under
this Article in the case of the transit of animals by means of a trailer
attached either to a motor vehicle constructed solely for the
carriage of passengers and their effects or to an agricultural tractor,
nor in respect of the use of a vehicle for the following purpose,
that is to say—
