

**Variation of Order in Council as to Establishment of
Ministry of Public Security.**

ORDER IN COUNCIL, DATED 2ND JULY, 1941, MADE UNDER SUB-SECTION (3) OF SECTION THREE OF THE MINISTRIES ACT (NORTHERN IRELAND) 1940.

BY THE GOVERNOR IN THE PRIVY COUNCIL OF NORTHERN IRELAND.

ABERCORN.

WHEREAS by an Order in Council made by the Governor of Northern Ireland on the 15th day of August, 1940, in pursuance of sub-section (1) of section three of the Ministries Act (Northern Ireland), 1940 (hereinafter referred to as "the principal Order in Council") provision was made, among other things, that reference to the Ministry of Home Affairs occurring in the Civil Defence Acts (Northern Ireland), 1938 and 1939, should be construed as references to the Ministry of Public Security :

AND WHEREAS by an Order made by the said Governor on the 6th day of May, 1941, in pursuance of sub-section (3) of section three of the said Act, an order theretofore made by the said Governor in pursuance of sub-section (3) of section one of the said Act was varied in the manner in the first mentioned order appearing :

AND WHEREAS it is expedient, by reason of the first mentioned order, that the principal Order in Council should be varied so as to have effect in the manner hereinafter appearing :

NOW, THEREFORE, I, JAMES ALBERT EDWARD, DUKE OF ABERCORN, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland, by and with the advice of the Privy Council of Northern Ireland, in exercise of the powers conferred upon me by sub-section (3) of section three of the said Act, and of all other powers enabling me in this behalf, do hereby order as follows :—

The principal Order in Council shall have effect as if the following words were added to paragraph I of Part II of the Schedule thereto :—

- “ except the enactments of the Civil Defence Act (Northern Ireland), 1939, which relate to the following functions, that is to say—
- (a) functions exercisable by the appropriate department under the said Act in relation to any railway or water undertaking ;
 - (b) functions exercisable under Part VI of the said Act ;
 - (c) functions exercisable under section forty-nine of the said Act ;

- (d) functions exercisable under the said Act, so far as they relate to, or are connected with, the purposes of Part VI and section forty-nine of the said Act."

Variation of Order as to Transfer of Functions to Ministry of Public Security.

ORDER DATED THE SIXTH DAY OF MAY, 1941, MADE BY THE GOVERNOR OF NORTHERN IRELAND UNDER SUB-SECTION (3) OF SECTION THREE OF THE MINISTRIES ACT (NORTHERN IRELAND), 1940.

WHEREAS by an order made by the Governor of Northern Ireland on the 25th day of June, 1940, in pursuance of sub-section (3) of section one of the Ministries Act (Northern Ireland), 1940 (hereinafter referred to as "the principal order") certain functions exercisable by the Ministry of Home Affairs, as mentioned in the principal order, were transferred to the Ministry of Public Security :

AND WHEREAS by sub-section (3) of section three of the said Act it is provided that any order made under the said Act may be varied by a subsequent order ;

AND WHEREAS it is expedient that the principal order should be varied so as to have effect in the manner hereinafter appearing :

NOW I, JAMES ALBERT EDWARD, DUKE OF ABERCORN, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland; in exercise of the powers conferred upon me by sub-section (3) of section three of the said Act, and of all other powers enabling me in this behalf, do hereby order as follows :—
