Variation of Order as to Transfer of Functions to Ministry of Public Security.

ORDER DATED THE SIXTH DAY OF MAY, 1941, MADE BY THE GOVERNOR OF NORTHERN IRELAND UNDER SUB-SECTION (3) OF SECTION THREE OF THE MINISTRIES ACT (NORTHERN IRELAND), 1940.

BY THE GOVERNOR OF NORTHERN IRELAND.

ABERCORN.

WHEREAS by an order made by the Governor of Northern Ireland on the 25th day of June, 1940, in pursuance of sub-section (3) of section one of the Ministries Act (Northern Ireland), 1940 (hereinafter referred to as "the principal order") certain functions exercisable by the Ministry of Home Affairs, as mentioned in the principal order, were transferred to the Ministry of Public Security :

AND WHEREAS by sub-section (3) of section three of the said Act it is provided that any order made under the said Act may be varied by a subsequent order ;

AND WHEREAS it is expedient that the principal order should be varied so as to have effect in the manner hereinafter appearing :

NOW I, JAMES ALBERT EDWARD, DUKE OF ABERCORN, Knight of the Most Noble Order of the Garter, Knight of the Most Illustrious Order of Saint Patrick, Governor of Northern Ireland; in exercise of the powers conferred upon me by sub-section (3) of section three of the said Act, and of all other powers enabling me in this behalf, do hereby order as follows :—

The principal order shall have effect as if the following words were added to paragraph 1 thereof :—

“ except the following functions exercisable under the Civil Defence Act (Northern Ireland), 1939, that is to say—

- (a) functions exercisable by the appropriate department under the said Act in relation to any railway or water undertaking ;
- (b) functions exercisable under Part VI of the said Act ;
- (c) functions exercisable under section forty-nine of the said Act ;
- (d) functions exercisable under the said Act, so far as they relate to, or are connected with, the purposes of Part VI and section forty-nine of the said Act ;”

and, accordingly, the functions exercisable under the enactments hereinafore mentioned of the Civil Defence Act (Northern Ireland), 1939, shall be exercisable by the Ministry of Home Affairs.

MOTOR VEHICLES AND ROAD TRAFFIC.

Road Vehicles.

Licensing : Leave Permit.

REGULATIONS, DATED 18TH MARCH, 1941, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER SECTION 2 OF THE FINANCE ACT (NORTHERN IRELAND), 1940.

1941. No. 60.

The Ministry of Home Affairs, in exercise of the powers vested in it by Section 2 of the Finance Act (Northern Ireland), 1940, and of all other powers in that behalf thereunto enabling the Ministry, hereby makes the following regulations ;—

1.—(1) A permit issued under Section 2 of the Finance Act (Northern Ireland), 1940, shall be :—

- (a) in respect of a vehicle stated in the Registration Book thereof to be a private vehicle, in the Form A in the Schedule hereto ; and
- (b) in respect of a vehicle stated in the Registration Book thereof to be a cycle, in the Form B in the said Schedule.

(2) The authority by whom such Permits may be granted shall be the Council of the county or county borough in whose area the vehicle is ordinarily kept.
