### PUBLIC SECURITY.

Now, THEREFORE, the Ministry, in exercise of the powers conferred upon it by the Ministries Act (Northern Ireland), 1940, hereby orders as follows :—

1.—Subject as hereinafter provided, no person shall acquire in Northern Ireland any map of any part of Ireland drawn to a scale of ten miles to one inch or any larger scale, except under authority of a licence granted by a County Inspector or Commissioner of the Royal Ulster Constabulary.

2.—(1) Subject as hereinafter provided, no person shall sell any such map as aforesaid to any other person except upon production by that person of a licence so granted authorising him to acquire the map.

(2) Where any person sells any such map as aforesaid upon production of a licence, he shall endorse the fact of sale upon the licence and transmit the licence to the Officer of the Royal Ulster Constabulary by whom it was granted. Provided that where the licence authorises the acquisition of more than one map, it shall not be necessary so to transmit the licence until all the maps authorised by the licence to be acquired have been acquired by the holder of the licence.

3.—Nothing in this Order shall apply with respect to the acquisition of a map by any servant of His Majesty acting in the course of his duty as such.

4.—In this Order—

the expression "sell" includes distribute, dispose of and part with possession of, and the expression "sale" shall be construed accordingly.

5.—The Public Security (Maps) Order (Northern Ireland), 1940, is hereby revoked.

6.—This Order may be cited as the Public Security (Maps) Order (Northern Ireland), 1941.

#### **Prohibition of Processions.**

## 1941. No. 149.

WHEREAS it is provided by sub-section 2 of Section 1 of the Ministries Act (Northern Ireland), 1940, that the Ministry of Public Security for Northern Ireland (hereinafter referred to as "the Ministry") shall

have power to issue such Orders as the Minister of Public Security for Northern Ireland may consider necessary for public security, civil defence, the preservation of the peace and the maintenance of order, the co-ordination of the civil defence services, and the protection of persons and property from injury or damage in the present emergency :

AND WHEREAS on the 4th day of July, 1940, the Public Security (Prohibition of Processions) Order (Northern Ireland), 1940, (hereinafter referred to as "the principal Order") was made by the Ministry :

AND WHEREAS on the 30th day of November, 1940, the Public Security (Prohibition of Processions) (Amendment) Order (Northern Ireland), 1940, was made by the Ministry amending the principal Order :

AND WHEREAS it is expedient that the principal Order should now be further amended :

Now, THEREFORE, the Ministry, in exercise of the powers conferred upon it by the Ministries Act (Northern Ireland), 1940, hereby orders as follows :—

1.—The Public Security (Prohibition of Processions) (Amendment) Order (Northern Ireland), 1940 is hereby revoked.

2.—There shall be substituted for Article 4 of the principal Order the following Article :—

"4 (1) This Order shall not apply-

- (a) to anything done in the course of their duty by members of any of His Majesty's Forces or Police Officers or Constables or members of any civil defence organisation, or
  - (b) to any procession for the holding of which an authorisation in writing has been given by the Ministry, provided that an authorisation shall not be given for any procession save a procession in respect of which the Ministry is satisfied that the holding thereof is for an object directly connected with, or likely to further, the more effective prosecution of the war.
- (2) The Ministry may delegate its power to give such authorisation as aforesaid to any Officer of the Royal Ulster Constabulary holding a rank not lower than the rank of District Inspector."

3.—This Order may be cited as the Public Security (Prohibition of Processions) (Amendment) Order (Northern Ireland), 1941, and this Order and the Principal Order may be cited together as the Public Security (Prohibition of Processions) Orders (Northern Ireland), 1940 and 1941.
