REGULATIONS, DATED 29TH SEPTEMBER, 1941, MADE BY THE MINISTRY OF PUBLIC SECURITY UNDER THE SPECIAL CONSTABLES ACT, 1914, AS EXTENDED AND AMENDED BY SECTION 8 OF THE CONSTABULARY ACT (NORTHERN IRELAND), 1922, AND THE MINISTRIES ACT (NORTHERN IRELAND), 1940.

1941. No. 173.

WHEREAS by the Special Constables Act, 1914, as extended and amended by section eight of the Constabulary Act (Northern Ireland), 1922, sub-section (2) of section one of the Ministries Act (Northern Ireland), 1940, and an order made by the Governor of Northern Ireland in pursuance of sub-section (3) of the last-mentioned section, power is conferred upon the Ministry of Public Security to make regulations with respect to the appointment and position of Special Constables in Northern Ireland :

AND WHEREAS it was provided by section five of the Special Constables (Ireland) Act, 1832, that a Special Constable appointed thereunder should have all such powers, privileges and duties as any constable duly appointed then had by virtue of the common law or of any statute :

AND WHEREAS by virtue of subsequent enactments various other powers, privileges and duties have been from time to time conferred and imposed upon constables :

AND WHEREAS certain of the last mentioned powers, privileges and duties are exercisable by, and conferred and imposed upon, members of the Royal Ulster Constabulary only, and it is expedient to provide, to the extent hereinafter appearing, that the same should be exercisable by, and conferred and imposed upon, Special Constables :

Now, THEREFORE, the Ministry of Public Security, in exercise of the power conferred upon it as aforesaid, and of all other powers enabling it in that behalf, hereby makes the following regulations :---

1.—In addition to the powers, privileges and duties exercisable by, and conferred and imposed upon, Special Constables by virtue of section five of the Special Constables (Ireland) Act, 1832, or by virtue

of any subsequent enactment, every Special Constable, whether appointed for whole-time service or for part-time service, shall, when on duty as a Special Constable, have all other the powers, privileges and duties which members of the Royal Ulster Constabulary may have by virtue of any statute, order or regulation for the time being in force, being powers, privileges and duties relating to matters in respect of which the Parliament of Northern Ireland has power to make laws.

2.—(1) These Regulations shall be construed as one with the regulations relating to the appointment and position of Special Constables made by the Minister of Home Affairs on the 29th day of November, 1922.

(2) The regulations relating to the appointment and position of Special Constables made by the Ministry of Public Security on the 21st day of April, 1941, are hereby revoked.

3.—These Regulations may be cited as the Special Constables Regulations (Northern Ireland), 1941.
