ORDER, DATED 6TH DECEMBER, 1941, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER REGULATION 70 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1941. No. 200.

The Ministry of Home Affairs for Northern Ireland by virtue of the powers conferred on it by Regulation 70 of the Defence (General) Regulations, 1939, hereby makes the following Order:—

1.—A person shall not drive or cause to be driven a goods vehicle on any of the roads described in the Schedule hereto unless—

- (a) the goods vehicle is proceeding to or from any private residence or other premises or any lands on or adjoining any such road ;
- or
- (b) the goods vehicle is being driven with the permission of the Secretary of the County Council in whose area any such roads are situate.

2.—In this Order the expression “ goods vehicle ” means a motor-car constructed or adapted for use for the carriage of goods or a trailer so constructed or adapted.

3.—This Order may be cited as “ The Restriction of Traffic (Goods Vehicle) (County Down) (Northern Ireland) Order, 1941.”

ORDER, DATED 6TH DECEMBER, 1941, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER REGULATION 70 OF THE DEFENCE (GENERAL) REGULATIONS, 1939:

The Ministry of Home Affairs for Northern Ireland by virtue of the powers conferred on it by Regulation 70 of the Defence (General) Regulations, 1939, hereby makes the following Order :—

1.—A person shall not drive or cause to be driven a goods vehicle on any of the roads described in the Schedule hereto unless—

- (a) the goods vehicle is proceeding to or from any private residence or other premises or any lands on or adjoining any such road ;
- or
- (b) the goods vehicle is being driven with the permission of the Secretary of the County Council in whose area any such roads are situate.

2.—In this Order the expression “ goods vehicle ” means a motor-car constructed or adapted for use for the carriage of goods or a trailer so constructed or adapted.
