WHEREAS, by Section 2 of the Constabulary Act (Northern Iteland), 1922, and by sub-section (1) of Section 4 of the Constabulary and

#### POLICE.

Police (Ireland) Act, 1919, as applied by the said Act of 1922, the Minister of Home Affairs is empowered to make orders as to the pay, pensions, and allowances of members of the Royal Ulster Constabulary, and by any such order to prescribe the rates and scales of pay, pensions, and allowances aforesaid :

AND WHEREAS the Governor of Northern Ireland has, in pursuance of powers vested in him by sub-section (3) of Section 1 of the Ministries Act (Northern Ireland), 1940, made an Order transferring to the Ministry of Public Security the functions excercisable by the Minister of Home Affairs in relation to the Royal Ulster Constabulary (except functions exercisable under the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 and 1933):

**1.**—After sub-section (a) of Article 5 of the Royal Ulster Constabulary Pensions Order, 1923, there shall be inserted, with effect from the 1st June, 1922, the sub-section set forth in the appended Schedule.

2.—And it is hereby certified that sub-section (2) of Section 4 of the Constabulary and Police (Ireland) Act, 1919, which provides for the submission of a draft of any Order proposed to be made under the said Section to the representative body or bodies constituted by the Act, and representing any rank or ranks affected, and for the consideration of any representations made by such body or bodies, has been fully observed.

3.—This Order may be cited as the Royal Ulster Constabulary Pensions (Amending) Order, 1941, and shall be construed as one with the Royal Ulster Constabulary Pensions Order, 1923, the Royal Ulster Constabulary Pensions (Amending) Order, 1925, and the Royal Ulster Constabulary Pensions (Amending) Order, 1929.

(a): (a) a member of the Force who has been granted a compensation allowance in respect of service in the Royal Irish Constabulary, and whose combined service in the Royal Irish Constabulary and in the Force reckoned in accordance with Article 3 of the Royal Ulster Constabulary Pensions (Amending) Order, 1929, would, but for the payment of such compensation allowance, have entitled him to a pension shall, for the purpose of sub-section (a) of Article 5 of this Order, be regarded as having been granted a pension from the date of dis-charge and charge, and

Special Constabulary : Position of Special Constables. 

REGULATIONS, DATED 21ST APRIL, 1941, MADE BY THE MINISTRY OF PUBLIC SECURITY UNDER THE SPECIAL CONSTABLES ACT, 1914, AS EXTENDED AND AMENDED BY SECTION 8 OF THE CONSTABULARY Act (Northern Ireland), 1922, and the Ministries Act (Northern Ireland), 1940. 1941. No. 95.

WHEREAS by the Special Constables Act, 1914, as extended and amended by Section 8 of the Constabulary Act (Northern Ireland), 1922, power was conferred on the Minister of Home Affairs for Northern Ireland to make regulations with respect to the appointment and position of Special Constables in Northern Ireland.

AND WHEREAS by virtue of sub-section (2) of section one of the Ministries Act (Northern Ireland), 1940, and of an Order made by the Governor of Northern Ireland in pursuance of sub-section (3) of the said Section, the said power has been transferred to and is exercisable by the Ministry of Public Security :

Now, THEREFORE, the Ministry of Public Security, in exercise of the power conferred upon it as aforesaid and of all other powers enabling it in that behalf, hereby makes the following regulations :---

1.—Every Special Constable, whether appointed for whole time service or for part time service, shall, when on duty as a Special Constable, have all the powers, privileges and duties which a member of the Royal Ulster Constabulary has by virtue of the common law or of any statute for the time being in force except powers, privileges and duties relating to matters in respect of which the Parliament of Northern Ireland has not power to make laws.
