* These Orders, made by Northern Ireland authorities under powers conferred upon them by the Defence (General) Regulations, 1939, or delegated to them under those Regulations, are treated as Orders to which the Rules Publication Act (Northern Ireland), 1925, apply by virtue of an Order in Council (S. R. & O., 1940, No. 1750) dated 27th September, 1940, which added to Regulation 102A of the Defence (General) Regulations, 1939, the following paragraph:—

"(2) Where, for the purpose of any of these Regulations, any power is exercisable by the Governor of Northern Ireland (whether acting alone or in Council) or by any department of the Government of Northern Ireland, nothing in section 3 of the Rules Publication Act, 1893, shall apply to any order, rule or bye-law made in the exercise of the said power, but the order, rule or bye-law shall be deemed to be a statutory rule to which the Rules Publication Act (Northern Ireland), 1925, applies, notwithstanding that it does not relate to a matter in respect of which the Parliament of Northern Ireland has power to make laws."

ORDER, DATED 6TH JULY, 1942, MADE BY THE MINISTRY OF AGRICULTURE FOR NORTHERN IRELAND UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Agriculture for Northern Ireland, (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) Order, 1941, made by the Secretary of State under paragraph (1) of Regulation 102A of the said Regulations, and by a Direction given by the Secretary of State, on the thirtieth day of June, 1942, for the purposes of the said Order, hereby orders as follows:—

- 1.—If a crop growing on any agricultural land or harvested or lifted therefrom, or in the process of being harvested or lifted therefrom, or any corn or foodstuff is damaged, or goes to waste as a result of any failure or delay of the occupier of that land, or of the owner of the crop, corn or foodstuff, in taking such steps as are reasonable to keep the crop, corn or foodstuff in good condition, the occupier of that land or the owner of the crop, corn or foodstuff, as the case may be, shall be guilty of an offence against this Order.
- 2.—Any person authorised by the Ministry may enter upon any premises on which he has reason to believe that an offence against this Order is being committed, and carry out such inspection and examination of the premises, and of the crops, corn or foodstuff thereon, and take such samples thereof as he shall think fit.
- 3.—For the purposes of this Order "foodstuff" means any article which enters into, or is capable of being used in the composition, manufacture or preparation of food for human or animal consumption.
- 4.—This Order may be cited as the Waste of Agricultural Foodstuffs (Northern Ireland) Order, 1942, and shall come into force on the 6th day of July, 1942.
