All processes in the manufacture of

(a) paper or paper-board,

(b) viscose transparent paper or film, (c) flour from wheat,

- (d) provender and compound foodstuffs for animal feeding,
- (e) sodium carbonate by the ammonia soda or Solvay Process,
- (f) caustic soda by the ammonia soda or Solvay Process, or by continuous causticising.

In pursuance of sub-sections (3) (b) and (4) of Section 3 of the Intoxicating Liquor Act (Northern Ireland), 1923, as amended by the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925, and by the Exchequer and Financial Provisions (No. 2) Act (Northern Ireland), 1936, the Ministry of Finance hereby determines that the rates at which charges are to be levied in respect of all licences for the sale of intoxicating liquor by retail granted or renewed during the year ending 30th September, 1943, shall be thirteen shillings for each pound sterling of the maximum rates of charge authorised by sub-section (1) of Section 1 of the Intoxicating Liquor (Finance) Act (Northern Ireland), 1925.

REGULATIONS, DATED 16TH FEBRUARY, 1942, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER PART II OF THE LOCAL GOVERNMENT (RATING AND FINANCE) ACT (NORTHERN IRELAND), 1929, AS AMENDED BY THE LOCAL GOVERNMENT (FINANCE) ACT (NORTHERN IRELAND), 1936.

WHEREAS the Ministry of Home Affairs, in pursuance of the provisions of Part II of the Local Government (Rating and Finance) Act (Northern Ireland), 1929, as amended by the Local Government (Finance) Act (Northern Ireland), 1936, made regulations entitled The Local Government (Finance) Regulations (Northern Ireland), 1936, (hereinafter referred to as "the principal regulations");

AND WHEREAS the principal regulations have been amended by the Local Government (Finance) Regulations (Northern Ireland), 1938, and the Local Government (Finance) Regulations (Northern Ireland), 1940;

AND WHEREAS it is expedient that the principal regulations should be further amended in manner hereinafter appearing :

Now, THEREFORE, the Ministry of Home Affairs, in exercise of the powers vested in the Ministry by Part II of the Local Government (Rating and Finance) Act (Northern Ireland), 1929, as amended by the Local Government (Finance) Act (Northern Ireland), 1936, and of all other powers in that behalf enabling the Ministry, hereby makes the following Regulations :—
