ORDER, DATED 14TH JULY, 1942, MADE BY THE MINISTRY OF COMMERCE UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Commerce for Northern Ireland by virtue and in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Secretary of State hereby orders as follows :

1.—

- (i) Every person who produces or otherwise deals in bricks, stone, cement, tar, bitumen, sand or gravel, in Northern Ireland, or who brings bricks, stone, cement, tar, bitumen, sand or gravel into Northern Ireland shall, if required so to do hold the same at the disposal of the Ministry of Commerce, hereinafter called "the Ministry," and shall not sell or otherwise dispose of any bricks, stone, cement, tar, bitumen, sand or gravel except in accordance with such prices and terms (if any) as may from time to time be determined by the Ministry, and
- (ii) every such person shall furnish to the Ministry such estimates, returns or information in regard to his production, disposal and stocks as may be requested by the Ministry and shall upon request produce to any person authorised by the Ministry in that behalf such books, accounts or other documents relating to his undertaking as may be mentioned in the request, and
- (iii) every such person shall carry out any directions given by the Ministry in regard to his production, treatment, keeping, storage, movement, transport, distribution, and disposal of bricks, stone, cement, tar, bitumen, sand or gravel.

2.—The Bricks and Stone (Control) Northern Ireland Order, 1941, is hereby revoked.

3.—This Order may be cited as the Civil Engineering Materials (Supplies Control) No. 1 (Northern Ireland) Order, 1942.
