

Subsidiary Employments.

PROVISIONAL SPECIAL ORDER, DATED 27TH JUNE, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, ACTING JOINTLY, UNDER PARAGRAPH (M) OF PART II OF THE FIRST SCHEDULE TO THE NATIONAL HEALTH INSURANCE ACT, 1936, AND BY THE SAID JOINT COMMITTEE, ACTING ALONE, UNDER THE PROVISO TO SECTION 2 (1) OF THE SAID ACT.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland hereby certify under sub-section (7) of Section 168 of the National Health Insurance Act, 1936, (hereinafter referred to as "the Act"), that it is expedient that this order should come into operation forthwith, and the said Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, in exercise of the powers conferred on them by paragraph (m) of Part II of the First Schedule to the Act, and of all other powers enabling them in that behalf, and the said Joint Committee, in exercise of the powers conferred on them by the proviso to sub-section (1) of Section 2 of the Act, and of all other powers enabling them in that behalf, and with the approval of the Ministry of Finance for Northern Ireland, hereby make the following order :—

1.—(1) This order may be cited as the National Health Insurance (Subsidiary Employments) Amendment Order (Northern Ireland), 1942.

(2) The Interpretation Act, 1921, applies to the interpretation of this order as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—The following provision shall be substituted for the provision relating to employment in Class "B" of the Ulster Special Constabulary contained in Part II of the First Schedule to the National Health Insurance (Subsidiary Employments) Order (Northern Ireland), 1938 (hereinafter referred to as "the principal order") :—

"Employment in the Ulster Special Constabulary."

3.—The following paragraph shall be added to Part II of the First Schedule to the principal order :—

"Employment, involving part time service only, by the Ministry of Agriculture for Northern Ireland, in collecting and furnishing information about prices in local fairs or markets."

4.—The words "Class 'B' of" shall be omitted from paragraph 5 of the Second Schedule to the principal order.

REGULATIONS, DATED 28TH MARCH, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 8 (1) OF PART I OF THE NATIONAL HEALTH INSURANCE, CONTRIBUTORY PENSIONS AND WORKMEN'S COMPENSATION ACT, 1941, AS APPLIED TO NORTHERN IRELAND BY THE NATIONAL HEALTH INSURANCE AND CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1941.
