

- (3) For the purposes of these Amending Regulations the term "Salary" as defined in the Principal Regulations shall be deemed not to include any war bonus paid to the teacher either under the aforesaid Amending Regulations No. 1, 1941, or under these Amending Regulations.

3.—These Regulations shall henceforth be construed with and as forming part of the Principal Regulations.

War Service of Preparatory and Secondary Teachers.

REGULATIONS, DATED 15TH JULY, 1942, MADE BY THE MINISTRY OF EDUCATION UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939.

1942. No. 124.

1.—These Regulations may be cited as "The Preparatory and Secondary Teachers' War Service Regulations, 1940, Amending Regulations, No. 1, 1942."

2.—The Preparatory and Secondary Teachers' War Service Regulations, 1940, (Statutory Rules and Orders of Northern Ireland, 1940, No. 31), which Regulations are hereinafter referred to as the "said Regulations" are hereby amended as follows:—

3.—Sub-section (*d*) of Article 2 of the said Regulations is hereby amended by the inclusion of the words "part-time teacher," after the words "full-time teacher."

After sub-section (*f*) of Article 2 of the said Regulations the following definition is hereby added:—

(*ff*) A "superannuated teacher" is a person who is in receipt of a pension under a Superannuation Scheme framed in pursuance of Section 70 of the Education Act, Northern Ireland, 1923, or a technical teacher who is in receipt of a pension under the provisions of Section 8 of the Local Government (Ireland) Act, 1919.

Sub-section (*i*) of Article 2 of the said Regulations is hereby repealed and the following sub-section is substituted therefor:—

- (i) A temporary war-time teacher means a person (including a superannuated teacher) who—
- (1) at the date of these Regulations was employed as a temporary teacher or as a substitute teacher under the Preparatory and Secondary Teachers' War Service Regulations, 1940 ;
 - (2) is appointed to fill a vacancy caused on the staff of a school by the absence of a teacher on leave on war service ;
 - (3) is temporarily employed in a school with the approval of the Ministry during the period of the present emergency.

4.—Article 6 of the said Regulations is hereby repealed and the following Article substituted therefor :—

- 6 (a) A temporary war-time teacher may be employed in any teaching capacity other than as a principal but shall cease to be recognised by the Ministry as a temporary war-time teacher as from such date as the Ministry may determine ;
- (b) A temporary war-time teacher who is not a superannuated teacher shall, if qualified in other respects, be eligible for appointment to a vacancy on the authorised staff of a school ;
- (c) A temporary war-time teacher who is not a superannuated teacher shall receive salary in accordance with the regulations applicable to full-time teachers on the authorised staff or to full-time teachers not on the authorised staff or to part-time teachers as the case may be ;
- (d) A temporary war-time teacher who is a superannuated teacher shall receive from the Governing Body of the school in which he is employed such salary as may be approved by the Ministry provided that the amount of such salary together with such pension or pensions as he may have been awarded by the appropriate Pension Authority or Authorities in Northern Ireland or Great Britain or by the Governing Body of a recognised Preparatory, Intermediate or Secondary school or the Managers of a recognised Technical School in which he was previously employed shall not exceed the amount of salary which he received immediately prior to his retirement on pension ;
- (e) A temporary war-time teacher who is a superannuated teacher shall notwithstanding any of the provisions of the Superannuation Schemes framed in pursuance of Section 70 of the Education Act, Northern Ireland, 1923, or the provisions of the Superannuation (Teaching Services) Acts (Northern Ireland) 1926 to 1938, not be eligible for admission or re-admission to such Superannuation Schemes ;
- (f) Nothing in this Article shall prevent a temporary war-time teacher other than a superannuated teacher from being

considered for appointment to the ordinary staff of a school if otherwise eligible for such an appointment should a vacancy occur.

5.—Article 7 of the said Regulations is hereby repealed and the following Article substituted therefor :—

(7) A temporary war-time teacher other than a “super-annuated teacher” who fulfils the prescribed conditions for admission to the Superannuation Scheme may, if he so desires and the Governing Body agrees, be admitted to such Scheme.

6.—These Regulations shall be construed with and as forming part of the Preparatory and Secondary Teachers’ War Service Regulations, 1940, and shall have effect as from 1st August, 1942.

Public Elementary Schools : Amending Regulations.

REGULATIONS, DATED 26TH FEBRUARY, 1942, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 TO 1940, AFTER CONSULTATION WITH THE MINISTRY OF FINANCE.

1942. No. 43.

1.—These regulations may be cited as the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 13, 1942.

2.—The Public Elementary Schools Regulations, 1934 (Statutory Rules and Orders of Northern Ireland, 1934, No. 40), as amended by Statutory Rules and Orders of Northern Ireland, 1935, No. 69 ; 1936, No. 83 ; 1936, No. 159 ; 1937, No. 17 ; 1937, No. 57 ; 1937, No. 87 ; 1938, No. 28 ; 1938, No. 63 ; 1938, No. 125 ; 1939, No. 79 ; 1940, No. 21 ; and 1941, No. 73 ; which Regulations as so amended are hereinafter referred to as the “Principal Regulations,” are hereby amended as follows :—

3.—Clause (a) of Article 37 of the Principal Regulations is hereby repealed and the following clause substituted therefor :

37—(a) The morning “attendance” shall begin not later than 10.30 a.m., or 11 a.m. during Summer Time. The school shall, however, be in operation from 10.0 a.m. at the latest : Provided that, during the period from 4th April to 8th August, 1942, the time of beginning operation may be deferred until 10.30 a.m.
