for recognition as teacher prescribed in the Principal Regulations, may, if and when the said person is subsequently recognised as junior assistant mistress, assistant teacher, or principal teacher, be reckoned for increment in accordance with the conditions governing the award of increments contained in the Principal Regulations.

4.—These Regulations shall be construed with and as forming part of the Public Elementary School (Teachers' War Service) Regulations, 1940, and shall take and have effect from the date of those Regulations.

REGULATIONS, DATED 30TH JULY, 1942, MADE BY THE MINISTRY OF EDUCATION UNDER THE TEACHERS' SALARIES AND SUPERANNUATION (WAR SERVICE) ACT (NORTHERN IRELAND), 1939, AFTER CON-SULTATION WITH THE MINISTRY OF FINANCE.

1942. No. 135.

1.—These regulations may be cited as the Public Elementary School (Teachers' War Service) Regulations, 1940, Amending Regulations, No. 3, 1942.

2.—The Public Elementary School (Teachers' War Service) Regulations, 1940 (Statutory Rules and Orders of Northern Ireland, 1940, No. 16), as amended by the Public Elementary School (Teachers' War Service) Regulations, 1940, Amending Regulations No. 1, 1941, and No. 2, 1942 (Statutory Rules and Orders of Northern Ireland, 1941, No. 45, and 1942, No. 42) which Regulations, as so amended, are hereinafter referred to as the "said Regulations", are hereby amended as follows :—

3.—Sub-sections (b), (c), (d), (dd) and (e) of Article 4 of the said Regulations are hereby repealed and the following sub-sections substituted therefor :—

4. (b) (1) The substitute for a teacher who is absent on war service must possess the qualifications for recognition as assistant teacher (if the absent teacher is a principal or an assistant) or as junior assistant mistress (if the absent teacher is a junior assistant mistress) prescribed in the Principal Regulations : Provided, however, that in exceptional circumstances, where it is found impracticable to obtain a substitute possessing the prescribed qualifications, the Ministry may sanction the employment of a competent person possessing other qualifications.

ÉDUCÁTION.

(2) Notwithstanding anything contained in the Principal Regulations, recognised service as substitute for a teacher absent on war service, rendered by a person possessing the prescribed qualifications for recognition as teacher, may be reckoned for increment in accordance with the conditions governing the award of increments contained in the Principal Regulations.

(3) A substitute for a teacher absent on war service may be allowed payment for vacations, holidays and other days on which the school is closed, and for absence owing to illness or other causes, in accordance with the articles in the Principal Regulations which would be applicable if the substitute were serving as assistant or junior assistant mistress in the school.

(c) (1) Where the teacher who is absent on war service is a principal or assistant, the substitute, if qualified for recognition as assistant, shall be paid salary at the rate which would be applicable to him if he were recognised as assistant; if not so qualified, he shall be paid at the rate of f_{120} a year.

(2) Where the absent teacher is a junior assistant mistress, the substitute, if qualified for recognition as junior assistant mistress, shall be paid salary at the rate which would be applicable to her if she were recognised as such; if not so qualified, she shall be paid at the minimum rate of the scale which would be applicable to her if she were recognised as untrained junior assistant mistress in the school.

(3) Where the absent teacher is a principal, the teacher who discharges the duties of principal during such absence shall, provided that the school is in the category of average attendance of 30 and above, be eligible—

- (i) if an assistant or if the substitute for the absent principal—to receive an annual capitation grant for each pupil in average attendance at the rate of 9s. per pupil up to a limit of 120 pupils; 4s. 6d. per pupil in excess of 120 but not in excess of 600; and 2s. 6d. per pupil in excess of 600;
- (ii) if a vice-principal or a privileged assistant—to receive either the aforesaid annual capitation grant or to continue to receive the grant to which he is entitled as vice-principal or as privileged assistant, whichever is the greater.

(4) A substitute for a teacher who is absent on war service shall be eligible to receive grants for instruction in horticulture given in accordance with the provisions of the Principal Regulations, provided that he is recognised as qualified to give such instruction.

Teachers : Appointment and Transfer.

(5) A teacher recognised in a school a member of the staff of which is absent on war service shall not be regarded as ineligible to receive grants for instruction in horticulture solely by reason of the fact that a grant for instruction in horticulture is included in the remuneration of the absent teacher as calculated under Section 1 (2) of the Teachers' Salaries and Superannuation (War Service) Act, 1939. In this connection the term "teacher" includes the substitute for the teacher who is absent on war service.

(d) The foregoing sub-sections shall not operate so as—

- (i) to entitle a privileged assistant, a vice-principal, or an assistant teacher to receive a grant under sub-section (c) (3) of these Regulations in respect of service prior to 1st April, 1941; or
- (ii) to entitle any teacher to grants for horticulture in respect of instruction given prior to 1st April, 1942; or
- (iii) to entitle a substitute for a teacher absent on war service to an increase in payment, above the payment allowable under the sub-sections which are herein repealed, for any service given before 1st April, 1942.

4.—These Regulations shall be construed with and as forming part of the Public Elementary School (Teachers' War Service) Regulations, 1940, and, except as otherwise provided herein, shall take and have effect from the date of those Regulations.

1.—These Regulations may be cited as the Appointment and Transfer of Teachers (Provided and Transferred Schools) Regulations, 1942.

2.—(1) In every case to which sub-section (4) of section 3 of the Education Act (Northern Ireland), 1923, as amended by section 2 of the Education Act (Northern Ireland), 1930, and section 6 of the Education (Administrative Matters) Act (Northern Ireland), 1935, applies, in
