1.—(1) These regulations may be cited as the National Health Insurance (Insurance Practitioners' and Pharmaceutical Committees) Amendment Regulations (Northern Ireland), 1942, and shall be read as one with the National Health Insurance (Insurance Practitioners' and Pharmaceutical Committees) Regulations (Northern Ireland), 1936 (hereinafter referred to as "the principal regulations").

(2) In these regulations the expression "period of the present emergency" has the meaning assigned to it by Section 17 of the National Health Insurance and Contributory Pensions (Emergency Provisions) Act, 1939.

(3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2. Notwithstanding the provisions of regulation 13 of the principal regulations the term of office of persons who are members of a Local Insurance Practitioners' Committee, of the Central Insurance Practitioners' Committee or of the Local Pharmaceutical Committee at the date of these regulations shall, subject to the provisions of regulation 14 of those regulations, be extended to the 30th day of September first occurring not less than three months after the termination of the period of the present emergency.

REGULATIONS, DATED 9TH SEPTEMBER, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND, ACTING JOINTLY, UNDER SECTION 8 OF THE NATIONAL HEALTH INSURANCE, CONTRIBUTORY PENSIONS AND WORKMEN'S COMPENSATION ACT, 1941.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, in exercise of the powers conferred on them by section 8 of the National Health Insurance, Contributory Pensions and Workmen's Compensation Act, 1941, and of all other powers enabling them in that behalf, with the approval of the Ministry of Finance for Northern Ireland, hereby make the following regulations :—

1.—(1) These regulations may be cited as the National Health Insurance (Medical Benefit) (Emergency Provisions) Regulations (Northern Ireland), 1942, and shall come into force on the date hereof.

(2) In these regulations, the expression "period of the present emergency" has the meaning assigned to it in section 17 of the National Health Insurance and Contributory Pensions (Emergency Provisions) Act, 1939.

(3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—Paragraph (b) of sub-section (2) of section 35 of the National Health Insurance Act, 1936, as in force in Northern Ireland by virtue of section 213 of that Act, shall cease to have effect during the period of the present emergency.

3.—Paragraph 1 of the First Schedule to the National Health Insurance (Medical Benefit) Regulations (Northern Ireland), 1938, shall cease to have effect during the period of the present emergency without prejudice :—

- to the right of any practitioner to remain on the medical list whose name appears on that list at the date of these regulations; and
- (ii) to the powers of the Ministry of Labour for Northern Ireland, where it is of opinion that the circumstances so warrant, to add to the list the name of any practitioner resident in Northern Ireland (other than a practitioner disqualified from undertaking service by reason of his name having been removed, after an enquiry, from any medical list in Great Britain or Northern Ireland) subject to his acceptance of service upon the terms for the time being in operation in Northern Ireland.

THE NATIONAL HEALTH INSURANCE (MEDICAL BENEFIT) AMENDMENT REGULATIONS (NORTHERN IRELAND); 1942, DATED 11TH SEPTEMBER, 1942, MADE BY THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER THE NATIONAL HEALTH INSURANCE ACTS (NORTHERN IRELAND), 1936 TO 1941.

The Ministry of Labour for Northern Ireland, in exercise of the powers conferred on it by the National Health Insurance Acts (Northern Ireland), 1936 to 1941, and of all other powers enabling it in that behalf, hereby makes the following regulations :—

1. —These regulations may be cited as the National Health Insurance (Medical Benefit) Amendment Regulations (Northern Ireland), 1942, and shall be read as one with the National Health Insurance (Medical Benefit) Regulations (Northern Ireland), 1938, as subsequently amended, (hereinafter referred to as the "principal regulations").

2.—The following amendments shall be made in regulation 19 of the principal regulations :—

- (a) in paragraph (i) there shall be substituted for the words " nine shillings " the words " nine shillings and nine pence ".
- (b) in paragraph (ii) there shall be substituted for the word "fourpence" the words "fourpence halfpenny".

3.—In regulation 2 of these regulations sub-paragraph (a) shall be deemed to have had effect as from the 1st day of January, 1942, and sub-paragraph (b) to have had effect as from the 1st day of July, 1941.
