

the expression "workman" does not include any person employed otherwise than by way of manual labour whose remuneration exceeds two hundred and fifty pounds a year but save as aforesaid means a workman as defined by the Workmen's Compensation Act (Northern Ireland), 1927 (c) and any statutory modification thereof, being a workman who

- (a) is injured in Northern Ireland ; or
- (b) is injured outside Northern Ireland in circumstances in which compensation is payable in respect of such injury under any Act relating to workmen's compensation for the time being in force in Great Britain, Northern Ireland, the Isle of Man or Eire.

(2) The Interpretation Act, 1921 (d), shall apply for the purpose of the interpretation of this Warrant as it applies for the purpose of the interpretation of an Act of the Parliament of Northern Ireland.

9. This Warrant may be cited as the Injury Warrant, No. 2, (Northern Ireland), 1942.

THE UNEMPLOYMENT ASSISTANCE FUND (NORTHERN IRELAND) (CLOSING) ORDER, 1942, DATED 29TH JANUARY, 1942, MADE BY THE MINISTRY OF FINANCE UNDER SECTION 6 (2) OF THE DETERMINATION OF NEEDS ACT (NORTHERN IRELAND), 1941. (5 GEO. 6, c. 4).

WHEREAS it is provided by sub-section (1) of section six of the Determination of Needs Act (Northern Ireland), 1941, that the Unemployment Assistance Fund (Northern Ireland) shall in accordance

with directions given by the Ministry of Finance be wound up and closed, and the operation of certain other provisions of that Act is defined by reference to such date as the Ministry of Finance may by order declare to be the date on which the said fund is to be closed.

Now, THEREFORE, the Ministry of Finance hereby makes the following order :—

1. The thirty-first day of March, nineteen hundred and forty-two is declared to be the date on which the Unemployment Assistance Fund (Northern Ireland) is to be closed.

2. This order may be cited as the Unemployment Assistance Fund (Northern Ireland) (Closing) Order, 1942.

Determination of Need.

REGULATIONS, DATED AUGUST 4, 1942, MADE BY THE MINISTRY OF LABOUR UNDER THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934.

1942. No. 129.

WHEREAS the Ministry of Labour for Northern Ireland (hereinafter referred to as "the Ministry") in pursuance of the powers conferred on it by the Unemployment Assistance Act (Northern Ireland), 1934 (hereinafter referred to as "the Act"), duly made for the purposes of the Act the Unemployment Assistance (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1936 to 1941, and it is expedient to amend the said Regulations :

Now, THEREFORE, the Ministry, after consideration of draft Regulations prepared and submitted to the Minister of Labour for Northern Ireland by the Assistance Board for Northern Ireland, by virtue of the powers conferred on it by sections 33 and 46 of the Act and of all other powers in that behalf hereby makes the following Regulations :—

1.—(1) These Regulations may be cited as the Unemployment Assistance (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1942, and shall come into force on the seventeenth day of August, 1942, and these Regulations and the Unemployment Assistance (Determination of Need and Assessment of
