## MALONE TRAINING SCHOOL.

### Regulations.

REGULATIONS MADE BY THE MINISTRY OF HOME AFFAIRS, WITH THE APPROVAL OF THE MINISTRY OF FINANCE, IN PURSUANCE OF THE PROVISIONS OF SECTION 3 (3) OF THE MALONE TRAINING SCHOOL ACT (NORTHERN IRELAND), 1926.

The Ministry of Home Affairs in exercise of the powers vested in it by Section 3 (3) of the Malone Training School Act (Northern Ireland), 1926, (16 & 17 Geo. V. Chapter 22), and with the approval of the Ministry of Finance, hereby makes the following Regulations :—

- (1) The contribution payable by the Council of the County or County Borough in accordance with the provisions of subsection (3) of Section 3 of the above-mentioned statute, towards the expenses of a youthful offender who has been sent to the Reformatory School pursuant to an Order shall, from the first day of April, Nineteen hundred and forty-two, and until varied by any subsequent Order, be at the rate of Seventeen Shillings and Three Pence (17/3) per week during such time as such youthful offender is detained in the Reformatory School ;
- (2) Payment of the contribution as aforesaid shall be in arrear, and shall be made half-yearly by the Council of the County or County Borough in respect of the half-years ending 30th September and 31st March, respectively, and shall be made not later than two months from the date of the claim for payment ;
- (3) The Regulations made by the Ministry of Home Affairs, dated 26th day of August, 1941, and approved by the Ministry of Finance on the Twenty-ninth day of August in the year One thousand nine hundred and forty-one, are hereby revoked.

**Milk Regulations.***Grade A.*

REGULATIONS (GRADE A), DATED 30TH SEPTEMBER, 1942, MADE BY THE MINISTRY OF AGRICULTURE UNDER SECTION 9 OF THE MILK AND MILK PRODUCTS ACT (NORTHERN IRELAND), 1934.

1942. No. 159.

The Ministry of Agriculture, in exercise of the powers conferred on it by Section 9 of the Milk and Milk Products Act (Northern Ireland), 1934, and of any other powers enabling it in that behalf, hereby makes the following Regulations, that is to say—

1.—Part V of the Milk (Grade A) Regulations (Northern Ireland), 1934 (a), and paragraph 1 of the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1938 (b), are hereby revoked.

2.—These Regulations may be cited as the Milk (Grade A) (Amendment) Regulations (Northern Ireland), 1942, and shall have effect as from 1st day of October, 1942.
