

“ Meat ” means any part of the carcase (including the bones and offal of an animal) ;

“ Swill ” means any broken or waste foodstuffs including table or kitchen refuse, scraps or waste containing meat or vegetables.

*Offences.*

3.—If anything is done, or omitted to be done, in contravention of this Order, the owner and person in charge of the animals, and the owner and person in charge of any of the foodstuffs specified in Article 1 of this Order in respect of which the contravention is committed, and the person causing, directing, or permitting the contravention, shall each according to and in respect of his or their own acts or omissions be deemed guilty of an offence against the Diseases of Animals Act, 1894.

*Commencement.*

4.—This Order shall come into operation on the date hereof.

*Short Title.*

5.—This Order may be cited as the Boiling of Animal Food (Northern Ireland) Order of 1942.

**Compensation for Exported Animals.**

ORDER, DATED THE 1ST DAY OF NOVEMBER, 1942, MADE BY THE MINISTRY OF AGRICULTURE UNDER THE EXPORTED ANIMALS (COMPENSATION) ACTS (NORTHERN IRELAND), 1928 TO 1941.

The Ministry of Agriculture for Northern Ireland (hereinafter referred to as the Ministry) by virtue and in exercise of the powers vested in it under the Exported Animals (Compensation) Acts (Northern Ireland), 1928 to 1941, (hereinafter referred to as the Acts) as amended and adapted by any subsequent enactments and of every other power enabling it in that behalf orders, and it is hereby ordered as follows :—

*Suspension of Charges.*

1. The Ministry having been advised by the Trustees appointed for the purposes of the Acts that the Compensation Fund established under

the Acts is sufficient to meet all charges which may reasonably be expected to be payable from the Fund during the ensuing six months, and after consultation with the Trustees, suspends the payment by owners of animals exported to Great Britain from Northern Ireland of the charges required by the Acts as on and from the date hereof until the 1st November, 1943.

*Short Title.*

2. This Order may be cited as the Exported Animals (Compensation) Acts (Northern Ireland), 1928 to 1941 (Suspension of Charges) Order, 1942.

**Foot-and-Mouth Disease.**

The Ministry of Agriculture for Northern Ireland, by virtue and in exercise of the powers vested in it under the Diseases of Animals Act, 1894, as amended and adapted by any subsequent enactments and of every other power enabling it in that behalf, orders, and it is hereby ordered as follows :—

*Revocation of Orders.*

1. From and after midnight on the 1st day of March, 1942, the following Foot-and-Mouth Disease (Northern Ireland) Orders of 1941, that is to say, Nos. 11 and 24, are hereby revoked, in so far as the provisions of the said Orders apply to live sheep, goats, and swine.

2. Nothing in this Order shall affect anything previously done under the Orders hereby revoked.

*Short Title.*

3. This Order may be cited as the Foot-and-Mouth Disease (Northern Ireland) (Amendment) Order of 1942.
