#### EDUCATION.

### Regulations, dated 23rd November, 1942, made by the Ministry of Education under the Education Acts (Northern Ireland), 1923 to 1942, after consultation with the Ministry of Finance.

1.—These regulations may be cited as the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 15, 1942.

2.—The Public Elementary Schools Regulations, 1934 (Statutory Rules and Orders of Northern Ireland, 1934, No. 40), as amended by Statutory Rules and Orders of Northern Ireland, 1935, No. 69; 1936, No. 83; 1936, No. 159; 1937, No. 17; 1937, No. 57; 1937, No. 87; 1938, No. 28; 1938, No. 63; 1938, No. 125; 1939, No. 79; 1940, No. 21; 1941, No. 73; 1942, No. 43; and 1942, No. 47; which Regulations as so amended are hereinafter referred to as the "Principal Regulations", are hereby amended as follows :—

3.—The period during which Clause (c) of Article 66 of the Principal Regulations shall cease to have effect in so far as it is applicable to the recognition of men teachers shall be extended to 31st December, 1944.

4.—The proviso to Article 85 (c) of the Principal Regulations is amended with effect from 1st July, 1942, by the insertion of the words "at the appropriate rate set forth in Clause (d) of Article 88" after the words " (of the same sex as the absent teacher)".

5.—The proviso to Article 131 (a) of the Principal Regulations is repealed as from 30th June, 1938, and the following substituted therefor with effect from 1st July, 1938—

"Provided that where a teacher, in order to obtain the special qualifications at (1) or (2) hereof, remained at a Training College for either one or two additional years over and above the normal course of training, the premium may be awarded from the beginning of one year's service or two years' service, as the case may be, immediately preceding the date of full recognition, but in no case may a premium be paid for a University Degree or Diploma or other special qualification from a date earlier than that on which the qualification was conferred."

6.—Article 200 of the Principal Regulations is repealed and the following Article substituted therefor as from 1st January, 1943;

"200. Application for junior pupil teacherships must be made on the prescribed form which must be received in the Ministry, duly completed, not later than 1st March in the year in which appointment is sought, provided that applications received between 1st March and 15th March may, at the discretion of the Ministry, be accepted on payment of a late fee of ten shillings in respect of each applicant."

## Public Elementary Schools : Amending Regulations.

7.—Article 3 of the Public Elementary Schools Regulations, 1934, Amending Regulations No. 14, 1942, is hereby amended by the cancellation of the rates of temporary war bonus specified therein, as far as service rendered after 30th June, 1942, is concerned and the substitution therefor, in respect of recognised service rendered on and after 1st July, 1942, of the following rates :—

(i.) Principals, vice-principals, assistants, junior assistant mistresses and substitutes for teachers absent on leave on war service.

The bonus shall be remitted to the substitute by the Ministry. Where, under the Principal Regulations, the whole amount of the remuneration of the substitute is recoverable from the absent teacher by deduction from salary or otherwise, the whole amount of the bonus shall also be so recoverable, but in all other cases the cost of the bonus shall be borne in full by the Ministry.

(iii.) Teachers who are members of religious communities, who are serving in schools paid on the capitation system, and whose services are necessary in order to constitute the minimum teaching staff in the school in which they are employed.

Provided that where the school is an evacuating school the war bonus shall be payable in respect of members of the community for whom grants are payable in accordance with the terms of Article 11 (a) (4) of the Public Elementary Schools (Evacuated Children) Regulations, 1940, as amended by Article 7 of the Public Elementary Schools (Evacuated Children) Regulations, 1940, Amending Regulations No. 2, 1942.

8.—Sub-sections 2 and 3 of Article 3 of the Public Elementary Schools Regulations, 1934, Amending Regulations, No. 14, 1942 (Statutory Rules and Orders of Northern Ireland, 1942, No. 47), are hereby repealed as from 1st July, 1942, and the following sub-sections substituted therefor as from that date :

"3-(2) In this regulation the term "income" means the remuneration received by the teacher from the Ministry out of moneys provided by Parliament. for duty in a public elementary school, other than fées for evening school instruction, the value of any teacher's residence, and the temporary war bonus for which provision is herein made. Where a teacher is in receipt of compensation awarded by the Civil Service Committee under the Government of Ireland Act, 1920, for his removal from office in consequence of the transfer of the Model School in which he was serving to the local education authority, the said compensation shall be regarded as part of his income.

(3) The temporary war bonus shall not be reckonable for superannuation purposes."

### Public Elementary Schools : Evacuated Children.

REGULATIONS, DATED 26TH FEBRUARY, 1942, MADE BY THE MINISTRY OF EDUCATION UNDER THE EDUCATION ACTS (NORTHERN IRELAND), 1923 to 1940, after consultation with the Ministry of Finance.

### 1942. No. 44.

1.—These regulations may be cited as the Public Elementary Schools (Evacuated Children) Regulations, 1940, Amending Regulations, No. 2, 1942.

2.—The Public Elementary Schools (Evacuated Children) Regulations, 1940 (Statutory Rules and Orders of Northern Ireland, 1940, No. 15), as amended by the Public Elementary Schools (Evacuated Children) Regulations, 1940, Amending Regulations No. 1, 1941, (Statutory Rules and Orders of Northern Ireland, 1941, No. 72), which Regulations, as so amended, are hereinafter referred to as the "said Regulations," are hereby amended as follows :—

3.—Article 5 of the said Regulations is hereby amended by the addition thereto of the following sub-section :

5.—(c) Where an assigned teacher who is serving in an evacuating school is absent from duty therein in circumstances in which the employment of a substitute is, under the Regulations for Public Elementary Schools in force for the time being, a condition for the payment of salary for the period of absence, the Ministry, if it is satisfied—

(i) that the absent teacher is himself redundant in the school in which he is serving; or

(ii) that there is a redundant assigned teacher serving in the school who is available to take the place of the absent teacher;

may dispense with the requirement that a substitute shall be employed : Provided that in every such case there shall be deducted from the salary of the absent teacher the sum (if any) which would have been deducted under the said Regulations had a substitute been employed.
