

- (a) where a licence holder or his servant has been notified by a person, Company or other authority having custody for the time being of such feeding stuffs that those feeding stuffs are situate at the place at which the licence holder has agreed to accept delivery ; immediately after the receipt of such notification : or
- (b) where the feeding stuffs are conveyed to the licence holder's premises by a road vehicle arriving at such premises during the hours commencing one hour after sunrise and ending one hour before sunset : immediately on the arrival of such vehicle at such premises.

2.—This Order shall come into force on the 18th day of March, 1942.

DIRECTIONS, DATED 10TH DECEMBER, 1942, GIVEN UNDER THE BARLEY (CONTROL AND MAXIMUM PRICES) (NORTHERN IRELAND) ORDER, 1942.

1942. No. 197.

Pursuant to Article 14 of the Barley (Control and Maximum Prices) (Northern Ireland) Order, 1942 (a) as amended (b) the Ministry of Agriculture for Northern Ireland orders and directs as follows :—

1. No approved buyer shall—

- (a) sell or supply any barley purchased by him from a grower at a price exceeding 14s 6d per cwt. ex farm and not exceeding 30s per cwt. ex farm, to any person other than the Minister of Food ;
- (b) use or dispose of any such barley otherwise than for the purpose of such sale or supply.

2. Any approved buyer who offers any barley for sale to the Minister of Food shall furnish together with such offer a statement of the price at

which the barley offered was purchased by him and shall, if so requested by or on behalf of the Minister of Food, confirm such statement by a written certificate.

3. These directions shall not apply—

- (a) to any such barley bought by the approved buyer and delivered to him or to his order before the date of the coming into force of these Directions ;
- (b) to the use or sale of any such barley as Seed in accordance with Article 5 of the Barley (Control and Maximum Prices) (Northern Ireland) Order, 1942 ;
- (c) to the use of any such barley by a person who is a flour miller within the meaning of the Flour (Control and Prices) Order, 1941, (c) for the manufacture of flour for human consumption ;
- (d) to the sale or use of any such barley which an approved buyer shall have offered to the Minister at a price not exceeding 30s 7½d per cwt. ex farm, which he shall have certified to the Minister to be a price which does not exceed by more than 7½d per cwt. the price paid by him to the grower, and which the Minister shall have refused to purchase at the price at which the barley shall have been offered as aforesaid ;
- (e) to the extraction of Screenings from any such barley to the extent of not more than 5% of the bulk or to the sale or use of any such Screenings for feeding to livestock.

4. These Directions shall come into force on the 14th day of December, 1942, and shall apply only to Northern Ireland.
