Internees Regulations.

REGULATIONS, DATED 28TH DECEMBER, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR, ACTING JOINTLY, UNDER SECTION 8 OF THE NATIONAL HEALTH INSURANCE, CONTRIBUTORY PENSIONS AND WORKMEN'S COMPENSATION ACT, 1941.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly, in exercise of the powers conferred by Section 8 of the National Health Insurance, Contributory Pensions and Workmen's Compensation Act, 1941, and of all other powers enabling them in that behalf, and with the approval of the Ministry of Finance, hereby make the following regulations :—

1.—(1) These regulations may be cited as the National Health Insurance and Contributory Pensions (Internees) Regulations (Northern Ireland), 1942.

(2) In these regulations, unless the context otherwise requires—
“ the Insurance Act ” means the National Health Insurance Act, 1936, as amended by any subsequent enactment ;

“ the Insurance Acts ” mean the National Health Insurance Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment ; and

“ the Pensions Acts ” mean the Widows', Orphans' and Old Age Contributory Pensions Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment.

(3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—(1) Subject to the proviso to this paragraph, any person who at the 5th January, 1942, was interned outside the United Kingdom and His Majesty's dominions as a prisoner of war or otherwise, and who, on the date on which he was so interned, not being earlier than the 3rd September, 1939, was engaged in an employment which would have

been employment within the meaning of the Insurance Act if paragraph (a) of sub-section (1) of section 3 of the National Health Insurance, Contributory Pensions and Workmen's Compensation Act, 1941, had then been in force, shall be treated as if he :-

- (a) had become an employed contributor on the 5th January, 1942, had ceased on that date to be employed within the meaning of the Insurance Act and had then become entitled to a free insurance period as an employed contributor under section 6 of that Act ; and
- (b) had, for the purposes of the National Health Insurance and Contributory Pensions (Internees and Other Persons) Regulations (Northern Ireland), 1942, been interned on the 5th January, 1942, as a prisoner of war or otherwise :

Provided that this regulation shall not apply to any person who, on the date on which he was so interned, in addition to being insured or treated as insured under the Insurance Acts, was insured within the meaning of the Pensions Acts.

(2) Paragraph (b) of sub-section (1) of section 2 of the National Health Insurance and Contributory Pensions (Emergency Provisions) Act, 1939, shall not apply to a person to whom paragraph (1) of this regulation is applicable.
