

1.—No person shall lift potatoes of the varieties mentioned in the first column of the Schedule to this Order before the dates respectively set opposite thereto in the second column of the Schedule except under and in accordance with the terms of a licence issued by the Ministry.

2.—A licence issued by the Ministry under this Order shall specify :

- (i) the variety of potatoes to which it relates ;
- (ii) the land on which the potatoes to which it relates are growing ;
- (iii) the date on or after which it shall be lawful to lift the potatoes.

3.—In this Order “ potatoes ” means potatoes grown in Northern Ireland for the purpose of sale.

4.—This Order may be cited as the Lifting of Potatoes (Prohibition) (Northern Ireland) (No. 2) Order, 1942.

Horticultural Cropping.

ORDER, DATED 1ST JANUARY, 1942, MADE BY THE MINISTRY OF AGRICULTURE UNDER REGULATION 62 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1942. No. 3.

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under Regulation 62 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) Order, 1941, by the Secretary of State under paragraph (1) of Regulation 102A of the said Regulations, hereby orders as follows :—

1. Except in so far as the Ministry may otherwise agree in writing, the occupier of any glasshouse on a holding of agricultural land exceeding one quarter of an acre shall, if that glasshouse is used for producing crops for sale, comply with the following directions :—

- (a) No permanent crops shall after the date of this Order be planted in any such glasshouse.
- (b) No such glasshouse shall be used for producing tulips for sale. For the purpose of this provision of this Article the term "glasshouse" shall include any glazed horticultural frame or cloche.
- (c) If at the date of this Order any such glasshouse is planted wholly or partly with permanent crops, where such permanent crops consist of fruit crops an under crop of tomatoes to the fullest extent reasonably possible shall, so long as such permanent crops remain, be grown annually in that glasshouse, and where such permanent crops consist of flower crops (including decorative foliage and flower crops from bulbs) the area of such flower crops shall not after the first day of April, 1942, exceed 25 per cent. of the area of permanent flower crops grown in that glasshouse in the year 1939.
- (d) During a period of six months between the first day of March and the thirty-first day of October in any year so much of any such glasshouse as at the date of this Order was not planted with permanent crops and any part thereof from which permanent crops shall hereafter be removed shall be devoted wholly to the production of tomatoes.

2. In this Order the expression "permanent crops" means crops planted in the land and normally grown for a period of more than one year and includes grapes, peaches, figs, carnations and roses.

3. This Order may be cited as the Horticultural (Glasshouse Cropping) (Northern Ireland) Order, 1942.
