

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry"), by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) Order, 1941, (a) made by the Secretary of State under paragraph (1) of Regulation 102A of the Defence (General) Regulations, 1939, hereby orders as follows :—

1.—(1) On the occasion of a sale of grass seeds or clover seeds or of grass and clover seeds, for use by the purchaser in sowing down any land with or without a nurse crop, the seller shall furnish to the purchaser, and the purchaser shall obtain an invoice or other statement in writing showing—

- (a) the name and address of the seller,
- (b) the quantity and description of each kind of seed sold, whether the seeds are mixed before delivery or not,
- (c) the name and address of the purchaser, and
- (d) the date of sale.

(2) The purchaser shall retain the said invoice or statement and shall permit any officer authorised by or on behalf of the Ministry to inspect the same at any time while this order is in force.

2. This Order may be cited as the Grass Seeds (Northern Ireland) Order, 1942.

THE BUILDING AND CIVIL ENGINEERING LABOUR (NORTHERN IRELAND RETURNS) (No. 1) ORDER, 1942, DATED 10TH APRIL, 1942, MADE BY THE MINISTER OF COMMERCE UNDER REGULATION 56AB (8) OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Minister of Commerce, in exercise of the powers conferred on him by Regulation 56AB of the Defence (General) Regulations, 1939, hereby orders as follows :—

1. This Order applies to every person employing labour (whether before, at or after the date of this Order) in any of the activities mentioned in sub-paragraphs (a), (b), (i) and (ii) of paragraph 2 of Regulation 56AB of the Defence (General) Regulations, 1939, in respect of whom there is in force at or after the date of this Order a certificate or provisional certificate issued by the Minister that he is registered under the said Regulation.

2. Every person to whom this Order applies is hereby required to make to the Minister not later than the 14th day of each month a return as respects persons employed in any of the activities referred to in paragraph 1 hereof on the pay roll on the first Pay Day of the month to which the return relates, in such form and containing all such particulars and information as will be specified under this order by notice which will be sent by the Minister to all persons concerned.

3. This Order may be cited as the Building and Civil Engineering Labour (Northern Ireland Returns) (No. 1) Order, 1942.

THE CONTROL OF BUILDING OPERATIONS (NORTHERN IRELAND) ORDER, 1942, DATED 1ST JANUARY, 1942, BY THE MINISTRY OF COMMERCE UNDER REGULATION 56A OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

WHEREAS the Secretary of State is the competent authority under the provisions of Regulation 56A of the Defence (General) Regulations, 1939, in its application to Northern Ireland :
