REGULATIONS, DATED 28TH MARCH, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR FOR NORTHERN IRELAND UNDER SECTION 8 (1) OF PART I OF THE NATIONAL HEALTH INSURANCE, CONTRIBUTORY PENSIONS AND WORKMEN'S COMPENSATION ACT, 1941, AS APPLIED TO NORTHERN IRELAND BY THE NATIONAL HEALTH INSURANCE AND CONTRIBUTORY PENSIONS ACT (NORTHERN IRELAND), 1941.

## Internees.

The National Health Insurance Joint Committee and the Ministry of Labour for Northern Ireland, acting jointly, in exercise of the powers conferred by sub-section (1) of section 8 of Part I of the National Health Insurance, Contributory Pensions and Workmen's Compensation Act, 1941, as applied to Northern Ireland by the National Health Insurance and Contributory Pensions Act (Northern Ireland), 1941, and of all other powers enabling them in that behalf, and subject to the approval of the Ministry of Finance for Northern Ireland, hereby make the following Regulations :---

1.--(1) These regulations may be cited as the National Health Insurance and Contributory Pensions (Internees and Other Persons) Regulations (Northern Ireland), 1942, and shall have effect as from the 3rd September, 1939.

(2) In these regulations, unless the context otherwise requires—

- "the Insurance Acts" mean the National Health Insurance Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment;
- "the Pensions Acts" mean the Widows', Orphans' and Old Age Contributory Pensions Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment;
- "the Emergency Act of 1939" means the National Health Insurance and Contributory Pensions (Emergency Provisions) Act, 1939, as amended by any subsequent enactment;
- "the War Occupations Regulations" mean the National Health Insurance and Contributory Pensions (War Occupations) Regulations, 1940, as amended by any subsequent regulations;
- "the Ministry" means the Ministry of Labour for Northern Ireland;
- "enemy territory " means any area which is under the sovereignty of, or administered by, or for the time being in the occupation of or invaded by, a Power at war with His Majesty, but does not include any area for the time being in the occupation of His Majesty or of a Power allied with His Majesty, for the purposes of the present war;
- "interned " and "internment " include detention in pursuance of the Defence (General) Regulations, 1939, as subsequently amended, or in pursuance of the Aliens Order, 1920, as subsequently amended.

(3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—(1) Subject to the provisions of these regulations and to the necessary modifications, the provisions of sections 2, 4 and 5 of the Emergency Act of 1939 and section 1 of the National Health Insurance

and Contributory Pensions (Emergency Provisions) Act (Northern Ireland), 1939, (which relate to persons engaged in war occupations) and the War Occupations Regulations made thereunder shall, for the appropriate period or periods determined in accordance with paragraph (2) of this regulation, apply to any person who—

- (a) is, or was at any time from and including the 3rd September, 1939, interned as a prisoner of war or otherwise; or
- (b) is, or was at any time from and including that date, in Sweden or in any enemy territory, and by reason of the present war is or was unable to return to the United Kingdom;

and, for the purposes of the said sections and regulations as applied by these regulations but for those purposes only, any such person shall for the said period or periods be treated in the same manner as if he were engaged in a prescribed war occupation to which section 2 or, as the case may require, section 4 of the said first-mentioned Act, applies :

Provided that this regulation shall not apply to a person in respect of any such period if at any time during that period he was in the naval, military or air force of any Power not allied with His Majesty for the purposes of the present war, and sub-paragraph (b) of this paragraph shall not apply to a national of any such Power.

(2) For the purposes of paragraph (1) of this regulation, the appropriate period or periods in respect of a person shall be any one or more of the following periods applicable in his case :---

- (a) in the case of internment in the United Kingdom, the period of internment; and,
- (b) in the case of (i) internment outside the United Kingdom or (ii) absence abroad as specified in paragraph (1) of this regulation, the actual period of internment or the period of such absence, and in addition thereto the period immediately following thereafter terminating with the date of arrival of that person in the United Kingdom, subject to the qualification that if the latter period exceeds one month, that period shall be substituted by a period of one month or such longer period as the Ministry may in any particular case determine.

3.—(1) Any contributions under the Insurance Acts which have been paid in respect of any person in accordance with the provisions of paragraph (i) of regulation 2 of the National Health Insurance (Unclaimed Proceeds of Stamp Sales) Regulations, 1938, as amended by the National Health Insurance (Unclaimed Proceeds of Stamp Sales) Amendment Regulations, 1941, shall, for the purposes of paragraph (c)(i) of sub-section (1) of section 2 of the Emergency Act of 1939, be treated as having been duly paid by the person to whom they relate, and that paragraph shall apply accordingly.

(2) (a) Contributions payable under paragraph (c) (ii) of subsection (1) of section 2 of the Emergency Act of 1939 or by virtue of

paragraph (1) of regulation 8 of the War Occupations Regulations shall be deemed by the Ministry to have been paid in respect of a person (other than a person who has been interned by the Government of the United Kingdom, or of Northern Ireland, or of any other part of His Majesty's dominions) for the period or periods applicable in his case as specified in paragraph (2) of regulation 2.

(b) Any contributions so deemed shall, for the purposes of the Pensions Acts and in particular for the purposes of the said paragraph (c) (ii) or the said paragraph (1), as the case may require, be treated as if they had been paid and as having been paid by the person to whom they relate, and those Acts and paragraphs shall apply accordingly.

4.—Where by virtue of sub-section (1) of section 2 of the Emergency Act of 1939 the free insurance period or extended insurance period relating to a person is extended, he shall, for the purposes of that subsection and of these regulations, be treated as if he were entitled to such extension by virtue of section 6 or, as the case may require, section 7 of the National Health Insurance Act, 1936.

5.—The provisions of regulation 9 of the War Occupations Regulations as applied by these regulations shall, subject to the necessary modifications, also apply to any contributions which by virtue of subparagraph (a) of paragraph (2) of regulation 3 have been deemed by the Ministry to have been paid.

6.—In the application to Northern Ireland of paragraph (i) of regulation 2 of the National Health Insurance (Unclaimed Proceeds of Stamps Sales) Regulations, 1938, as amended by the National Health Insurance (Unclaimed Proceeds of Stamps Sales) Amendment Regulations, 1941, the reference to regulation 2 of the National Health Insurance and Contributory Pensions (Internees and Other Persons) Regulations, 1941, shall be read as a reference to regulation 2 of the National Health Insurance and Contributory Pensions (Internees and Other Persons) Regulations (Northern Ireland), 1942.

REGULATIONS, DATED 28TH DECEMBER, 1942, MADE BY THE NATIONAL HEALTH INSURANCE JOINT COMMITTEE AND THE MINISTRY OF LABOUR, ACTING JOINTLY, UNDER SECTION 8 OF THE NATIONAL HEALTH INSURANCE, CONTRIBUTORY PENSIONS AND WORKMEN'S COMPENSATION ACT, 1941.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly, in exercise of the powers conferred by Section 8 of the National Health Insurance, Contributory Pensions and Workmen's Compensation Act, 1941, and of all other powers enabling them in that behalf, and with the approval of the Ministry of Finance, hereby make the following regulations :—

1.—(1) These regulations may be cited as the National Health Insurance and Contributory Pensions (Internees) Regulations (Northern Ireland), 1942.

(2) In these regulations, unless the context otherwise requires—

- "the Insurance Act " means the National Health Insurance Act, 1936, as amended by any subsequent enactment;
- "the Insurance Acts "mean the National Health Insurance Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment; and
- "the Pensions Acts " mean the Widows', Orphans' and Old Age Contributory Pensions Acts (Northern Ireland), 1936 to 1941, as amended by any subsequent enactment.

(3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.

2.—(1) Subject to the proviso to this paragraph, any person who at the 5th January, 1942, was interned outside the United Kingdom and His Majesty's dominions as a prisoner of war or otherwise, and who, on the date on which he was so interned, not being earlier than the 3rd September, 1939, was engaged in an employment which would have
