3." Any books, notices or other documents required by this Order to be transmitted to the National Service Officer for any district. must be delivered or sent by post to the said Officer or delivered. or sent by post to the appropriate Employment Exchange for transmission to him."

5.—Paragraph (1) (c) of Article 11 of the principal Order shall have effect as if the words "the proviso to "were omitted therefrom.

Whereas by the Feeding Stuffs (Rationing) (Northern Ireland) Order, 1941 (a), it is provided that "rationed feeding stuff," means any feeding stuff which the Ministry of Agriculture for Northern Ireland (hereinafter referred to as "the Ministry") may by Directions made under that Order specify and that until the Ministry shall otherwise direct shall have the meaning assigned to it by the Schedule to that Order:

Now, THEREFORE, the said Ministry hereby orders and directs that the Schedule to that Order shall have effect as if dried liver meal were included therein.

This Order may be cited as the Feeding Stuffs (Rationing) (Dried Liver Meal) (Northern Ireland) Order, 1942.

ORDER, DATED 9TH JANUARY, 1942, MADE BY THE MINISTRY OF AGRICUL-TURE UNDER REGULATION 55 (1) OF THE DEFENCE (GENERAL) REGULATIONS, 1939. 1942. No. 8.

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of the Control of Fertilisers in Northern Ireland (Supply) (No. 1) Order, 1941, (a) made by the Minister of Supply under Regulations 55, 85 and 98 of the said Regulations, hereby orders as follows:-

- 1.—(1) Where a licensed retailer within the meaning of the Control of Fertilisers (Northern Ireland) (No. 1) Order, 1941 (b) as amended by the Control of Fertilisers (Northern Ireland) (No. 2) Order, 1941 (c) (which first-mentioned Order, as so amended, is in this Order referred to as "the principal Order"), disposes of any superphosphate, the licensed retailer shall furnish to the person who acquires the same, and that person shall obtain, at the time of such disposal, a statement in writing showing—
 - (a) the name and address of the licensed retailer,
 - (b) the name and address of the person acquiring the superphos-
 - (c) the quantity and class of superphosphate acquired, and
 - (d) the date on which the superphosphate is acquired.
- (2) Any person who obtains a statement in pursuance of the foregoing provisions shall retain the statement and shall permit any officer authorised by or on behalf of the Ministry to inspect the same at any time while this Order is in force.
- 2.—(1) This Order may be cited as the Control of Fertilisers (Northern Ireland) Order, 1942:
- (2) This Order shall be construed as one with the principal Order.
