agreement, shall dispose of that vehicle without the authority of a licence, if the person from whom he so regained possession acquired it under the authority of a licence.

6.—Paragraph 3 and paragraph 5 hereof shall not apply to :—

- (1) Government Departments; or
- (2) persons acquiring or disposing of—
 - (i) vehicles which by reason of their construction and the manner in which they are intended to be used would be chargeable with excise duty under sub-paragraphs (1), (2), (3) or (4) of paragraph 3 of the Schedule substituted by Section I of the Finance Act (Northern Ireland), 1937, for the second Schedule to the Finance Act, 1920,
- (ii) vehicles which are intended to be used in a manner which-
 - (a) would render them exempt from excise duty by reason of the provisions of sub-section (3) of section 4 of the Finance Act (Northern Ireland), 1924, or
 - (b) would entitle the persons in whose names they might be registered to apply for exemption from excise duty by reason of the provisions of sub-section (1) of section 4 of the Finance Act (Northern Ireland), 1937;
- (iii) vehicles which are road construction vehicles within the meaning of section 3 of the Finance Act (Northern Ireland), 1937, and are intended to be used for no purpose other than the construction or repair of roads at the public expense;

(iv) vehicles which are specially constructed, and intended to be used, solely for fire brigade purposes;

(v) road rollers.

7.—This Order may be cited as The Emergency Powers (Defence) Acquisition and Disposal of Motor Vehicles (Northern Ireland) Order, 1942.

1.—The Emergency Powers (Defence) Acquisition and Disposal of Motor Vehicles (Northern Ireland) Order, 1942, shall have effect as though the words "or a Motor Cycle" were deleted from the definition of "Passenger Vehicle" in paragraph 2 thereof.

2.—This Order shall come into force on the 8th day of June and may be cited as "The Emergency Powers (Defence) Acquisition and Disposal of Motor Vehicles (Amendment) (Northern Ireland), Order, 1942."

The Ministry of Home Affairs for Northern Ireland in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Home Affairs for Northern Ireland) Order, 1942, made by the Secretary of State under Paragraph (1) of Regulation 102A of the said Regulations hereby orders as follows :---

1. The Emergency Powers (Defence) Acquisition and Disposal of Motor Vehicles (Northern Ireland) Order, 1942, shall have effect as though the following sub-paragraph were added to paragraph 4 thereof :—

(4) Where the vehicle for which a licence is granted is required for the replacement of a registered vehicle, the registered vehicle shall be disposed of in such manner as may be required by the Ministry of Home Affairs and the vehicle acquired under the licence shall not, without the written authority of the Ministry of Home Affairs, be used until that requirement has been fulfilled."
