(b) in the case of works which are opened or re-opened after the date on which this Order comes into force, within 21 days after such opening or re-opening.

(2) The particulars required under paragraph (d) of Article 2 shall be furnished within one month after the end of the quarter to which they relate.

4. Every producer shall notify the Ministry if operation ceases at any of his works within 14 days after such cessation, stating whether it is proposed to close the works permanently or temporarily.

5. This Order shall come into force on the fourteenth day of December, 1943, and may be cited as the Sand and Gravel (Returns). (Northern Ireland) Order, 1943.

Order, dated January 21st, 1943, made by the Ministry of Commerce under Regulation 56AA of the Defence (General) Regulations, 1939.

## 1943. No. 10.

WHEREAS by letter of delegation dated 20th May, 1941, given by the Board of Trade under paragraph (2) of Regulation 56AA of the Defence (General). Regulations, 1939, the Board of Trade delegated to the Ministry of Commerce for Northern Ireland (in this Order referred to as "the Ministry") their functions under the said Regulation as respects any area in Northern Ireland. Now, THEREFORE, the Ministry, in exercise of the powers so delegated to it and of all other powers enabling it in that behalf, hereby makes the following Order :

1.—(1) This Order applies to premises situated in Northern Ireland which have a floor area of five thousand or more feet super, being premises which at the date of this Order were being used for any purposes (other than as living accommodation) in connection with the sale by wholesale or retail of articles of any description, but not being premises used wholly for the sale by wholesale or retail of food or drink for human or animal consumption, or hotels or restaurants.

(2) Every person who is the occupier of such premises shall furnish in writing on a form issued by the Ministry the particulars specified in the Schedule hereto and shall send such form within ten days of the receipt thereof to the Ministry at 31, Linenhall Street, Belfast.

2. In this Order the expression "premises" means any building or structure, and any number of separate premises which are in the occupation of one occupier and are situated within an area of one quarter of a square mile shall be treated as being parts of the same premises.

3. This Order may be cited as the Storage Facilities (Information) (Northern Ireland) Order, 1943.
