REGULATIONS, DATED AUGUST 14, 1943, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 33 (3) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934, AS APPLIED BY PART II OF THE OLD AGE AND WIDOWS' PENSIONS ACT (NORTHERN IRELAND), 1940.

1943 No. 103

WHEREAS the Ministry of Labour (hereinafter referred to as "the Ministry") in pursuance of the powers conferred on it by section 33 of the Unemployment Assistance Act (Northern Ireland), 1934, as that section is applied with respect to the functions of the Assistance Board for Northern Ireland by Part II of the Old Age and Widows' Pensions Act (Northern Ireland), 1940 (hereinafter referred to as "the Act"), duly made, for the purposes of Part II of the Act, the Supplementary Pensions (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1940 (hereinafter referred to as "the principal regulations "), the Supplementary Pensions (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1941, and the Supplementary Pensions (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1942 (hereinafter together referred to as "the amending regulations"), and whereas by reason of the Pensions and Determination of Needs Act (Northern Ireland), 1943, it is expedient to amend the said regulations:

Now, THEREFORE, the Ministry, after consideration of draft regulations prepared and submitted to the Minister of Labour by the Assistance Board for Northern Ireland, by virtue of the powers conferred on it by the Act and of all other powers in that behalf, hereby makes the following reguations:—

- 1.—(1) These regulations may be cited as the Supplementary Pensions (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1943, and shall come into force in relation to pensioners of any class on the first day after the thirtieth day of August, 1943, prescribed as the day of the week for the payment of supplementary pensions to pensioners of that class.
- (2) These regulations and the Supplementary Pensions (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1940 to 1942, shall be construed and may be cited together as the Supplementary Pensions (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1940 to 1943.
- (3) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. Where the applicant is a widow to whom an additional allowance in respect of a child is payable as part of her widow's pension, the amount to be added under sub-paragraph (3) (b) of paragraph 2 of the First Schedule to the principal regulations, as amended by the amending regulations, shall (instead of two shillings) be four shillings in respect of the applicant and an additional shilling in respect of each child whose needs have been included in the calculation, and accordingly there shall be added at the end of the said sub-paragraph (3) (b) the words:—
 - "unless the applicant is a widow to whom an additional allowance in respect of a child is payable as part of her widow's pension, in which case the further sum of four shillings in respect of the applicant and the additional sum of one shilling in respect of each child whose needs have been included in the calculation shall be added."
- 3. The maximum aggregate value of the money and investments treated as capital assets which are to be treated as equivalent to a specified weekly income by virtue of sub-paragraph (4) of paragraph 1 of Part I of the Second Schedule to the principal regulations, as amended by the amending regulations, shall be increased from three hundred pounds to four hundred pounds, and the weekly income to which they are to be treated as equivalent shall be reduced from one shilling to sixpence for every complete twenty-five pounds; and accordingly the said paragraph shall take effect as if in sub-paragraph (4) (b) thereof

"£400" were substituted for "£300" and the word "sixpence" were substituted for the words "one shilling", and as if in sub-paragraph (4) (c) thereof "£400" were substituted for "£300".

4. The amount of a superannuation payment to be disregarded by virtue of sub-paragraph (5) (d) of paragraph (1) of Part I of the Second Schedule to the principal regulations, as amended by the amending regulations, shall be the first ten shillings and sixpence a week, instead of the first seven shillings and sixpence a week, of the payment, provided that where the resources of the applicant include two or more such payments (whether receivable by the applicant or by any other person or persons) the amount of those payments to be disregarded shall not be more than the first ten shillings and sixpence a week of the aggregate amount of those payments: and accordingly the provisions of the said paragraph shall take effect as though in sub-paragraph (5) (d) thereof for the reference to seven shillings and sixpence there were substituted a reference to ten shillings and sixpence and as though at the end of the said sub-paragraph there were added the words:--" provided that where the resources of any applicant include two or more such payments (whether receivable by the applicant or by any other person or persons) the amount of those payments to be disregarded under this heading shall not be more than the first ten shillings and sixpence a week of the aggregate amount of those payments ".
