ORDER, DATED 12TH NOVEMBER, 1943, MADE BY THE MINISTRY OF COMMERCE FOR NORTHERN IRELAND UNDER REGULATIONS 55 AND 55AA OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1943. No. 124.

The Ministry of Commerce for Northern Ireland, by virtue and in exercise of the powers under Regulation 55 and 55AA of the Defence (General) Regulations, 1939, delegated to it by the Secretary of State hereby orders as follows :—

1. Any person who has in his possession or otherwise uses or deals in Contractors' Plant :
 - (a) shall keep, store, move, transport, distribute, dispose, acquire or use such plant in accordance with any Direction given by the Ministry,

- (b) shall not keep, store, move, transport, distribute, dispose, acquire or use in contravention of any Direction given by the Ministry,
 - (c) notwithstanding the provisions contained in subparagraphs (a) and (b) of this paragraph, this Order shall not apply to plant brought into Northern Ireland by Contractors who had originally obtained such plant outside Northern Ireland for use outside Northern Ireland nor to Contractors' Plant owned by Government Departments.
2. (i) Every person carrying on any undertaking involving the keeping, storage, movement, transport, distribution, disposal, acquisition or use of Contractors' Plant shall, if required so to do either by Notice served on him or by a Direction issued by the Ministry keep such books, accounts and records relating to the undertaking as may be prescribed by the Notice or Direction.
- (ii) Every person carrying on or employed in connection with any undertaking involving the keeping, storage, movement, transport, distribution, disposal, acquisition or use of Contractors' Plant shall, if required so to do either by Notice served on him or by a Direction issued by the Ministry or on behalf of the Ministry.
- (a) produce to the Ministry or to such person as may be mentioned in the Notice or Direction, such books, accounts or other documents relating to the undertaking as may be mentioned or described in the Notice or Direction; and
 - (b) furnish to the Ministry or to such person as may be mentioned in the Notice or Direction and within such period, and on and in such form (if any), as may be prescribed by the Notice or Direction, such estimates, returns or information relating to the undertaking, as may be mentioned or described in the Notice or Direction; and
 - (c) permit such person as may be authorised by the Ministry in that behalf, to enter and inspect any premises used for or in connection with the undertaking, with a view to securing compliance with this Order, and any person in possession of any such premises, and his agents and servants shall furnish the means required for such entry and inspection.
3. In this Order the expression " Ministry " means the Ministry of Commerce for Northern Ireland.

4. This Order shall come into force on the 12th day of November, 1943, and may be cited as the Contractors' Plant (Control) (Northern Ireland) Order, 1943.

DYEING AND CLEANING.

Direction.

ORDER, DATED FEBRUARY 26, 1943, MADE BY THE MINISTRY OF COMMERCE UNDER THE DYEING AND CLEANING (CONTROL) (NORTHERN IRELAND) ORDER, 1942.

1943. No. 30.

The Ministry of Commerce for Northern Ireland in pursuance of Article I of the Dyeing and Cleaning (Control) (Northern Ireland) Order, 1942, hereby orders and directs as follows :—

1. No person engaged in the business of dyeing and cleaning shall dye or clean or dye and clean or accept for dyeing or cleaning or dyeing and cleaning any articles of the description specified in the Schedule bearing the letters "A.V."

2. The provisions of this Order shall not apply to any person engaged in the business of dyeing and cleaning with whom a contract for the dyeing or cleaning or dyeing and cleaning of such articles has been made by or on behalf of a Government Department.

3. This Order may be cited as the Dyeing and Cleaning (Direction) (Northern Ireland) Order, 1943, and shall come into operation on the 1st day of March, 1943.
