Determinations.

THE SUPPLEMENTARY PENSIONS (DETERMINATIONS) (AMENDMENT) RULES (NORTHERN IRELAND) 1943, MADE BY THE ASSISTANCE BOARD FOR NORTHERN IRELAND UNDER PART II OF THE OLD AGE AND WIDOWS' PENSIONS ACT (NORTHERN IRELAND) 1940.

1943. No. 134.

WHEREAS in pursuance of the powers conferred by Part II of the Old Age and Widows' Pensions Act (Northern Ireland) 1940, the Supplementary Pensions (Determinations) Rules (Northern Ireland) 1940 (hereinafter called the "Principal Rules") were duly made for the purposes of that Act;

AND WHEREAS it is expedient that the Principal Rules should be amended in manner hereinafter appearing.

NOW, THEREFORE, the Assistance Board for Northern Ireland in pursuance of the powers conferred by Part II of the Old Age & Widows' Pensions Act (Northern Ireland) 1940, and of all other powers enabling it in that behalf, hereby makes the following rules:—

1. Rule 1 of the Principal Rules (which relates to the time at which applications may be made for supplementary pensions) shall have effect as if for paragraph (b) thereof there were substituted the following:—

“(b) in the case of a widow applying for a supplementary pension (i) if she is applying by virtue of entitlement to a widow's pension as part of which an additional allowance is payable, at any time after the date on which she receives notice that she has been awarded such a pension, and (ii) in any other case where application is made by virtue of entitlement to a widow's pension, at any time after the date on which she receives notice that she has been awarded a pension, or a date not more than one month before the date on which she attains the age of 60 years, whichever is the later”.

2. Rule 6 of the Principal Rules (which relates to the period for which a determination remains in force) shall have effect as though for the words “whichever is the shorter period” there were substituted the words “or until the expiration of six months after the due date of the last payment properly received by the applicant thereunder whichever period first expires”.

3. The schedule to these rules shall be substituted for the schedule to the Principal Rules.

4. (1) These rules may be cited as the Supplementary Pensions (Determinations) (Amendment) Rules (Northern Ireland) 1943, and may be cited together with the Principal Rules as the Supplementary Pensions' (Determinations) Rules (Northern Ireland) 1940 and 1943.

(2) These rules shall come into force on the day on which they are confirmed by the Minister of Labour for Northern Ireland.

REGULATIONS, DATED AUGUST 14, 1943, MADE BY THE MINISTRY OF LABOUR UNDER SECTION 33 (3) OF THE UNEMPLOYMENT ASSISTANCE ACT (NORTHERN IRELAND), 1934, AS APPLIED BY PART II OF THE OLD AGE AND WIDOWS' PENSIONS ACT (NORTHERN IRELAND), 1940.

WHEREAS the Ministry of Labour (hereinafter referred to as "the Ministry") in pursuance of the powers conferred on it by section 33 of the Unemployment Assistance Act (Northern Ireland), 1934, as that section is applied with respect to the functions of the Assistance Board for Northern Ireland by Part II of the Old Age and Widows' Pensions Act (Northern Ireland), 1940 (hereinafter referred to as "the Act"), duly made, for the purposes of Part II of the Act, the Supplementary Pensions (Determination of Need and Assessment of Needs) Regulations (Northern Ireland), 1940 (hereinafter referred to as "the principal regulations"), the Supplementary Pensions (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1941, and the Supplementary Pensions (Determination of Need and Assessment of Needs) (Amendment) Regulations (Northern Ireland), 1942 (hereinafter together referred to as "the amending regulations"), and whereas by reason of the Pensions and Determination of Needs Act (Northern Ireland), 1943, it is expedient to amend the said regulations :
