- (4) In proviso (iii), the words "two years" shall be substituted for the words "six months".
- 3. In paragraph (a) and paragraph (b) of Question 3 of the form of application contained in the First Schedule to the principal regulations, the word "three" shall be substituted for the word "two".
- 4. For the purposes of section 13 of the National Health Insurance and Contributory Pensions (Emergency Provisions) Act, 1939, the Insurance Section shall not be deemed to be a society.
- 5. So much of the Fourth Schedule to the National Health Insurance (Transitional) Regulations (Northern Ireland), 1940, as relates to regulation 4 of the principal regulations is hereby revoked, and subparagraph (e) of paragraph (1) of regulation 10 of the principal regulations, together with so much of the said Fourth Schedule as relates to it, is revoked as from the 1st July, 1940.

The National Health Insurance Joint Committee and the Ministry of Labour, acting jointly, in exercise of the powers conferred by the National Health Insurance Acts (Northern Ireland), 1936 to 1941, and of all other powers enabling them in that behalf, hereby make the following regulations:—

- 1.—(1) These regulations, which may be cited as the National Health Insurance (Juvenile Deposit Contributors) Amendment Regulations (Northern Ireland), 1943, shall be read as one with the National Health Insurance (Juvenile Deposit Contributors) Regulations (Northern Ireland), 1939 (hereinafter referred to as "the principal regulations"), and shall have effect as from the 1st January, 1942.
- (2) The Interpretation Act, 1921, applies to the interpretation of these regulations as it applies to the interpretation of an Act of the Parliament of Northern Ireland.
- 2. In paragraph (1) of regulation 3 of the principal regulations the words "thirteen shillings and sixpence" shall be substituted for the words "twelve shillings".
