Certification, Salaries and Employment.

REGULATIONS, DATED 19TH FEBRUARY, 1943, MADE BY THE MINISTRY OF Education under the Education Acts, 1923 to 1940, after consultation with the Ministry of Finance.

1943. No. 39.

1.--These Regulations may be cited as "The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2, Amending Regulations, No. 4, 1943."

2.—The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2, Statutory Rules and Orders of Northern Ireland, 1937, No. 89, as amended by Statutory Rules and Orders of Northern Ireland, 1941, Nos. 71 and 212 and 1942, No. 74, which Regulations as so amended are hereinafter referred to as the "Principal Regulations" are hereby amended as follows :—

3.—Article 2 of Statutory Rules and Orders of Northern Ireland, 1941, No. 71, is hereby amended as follows :—

Clause (a) is repealed and the following substituted therefor :---

- (a) "Teacher" is a full-time secondary or preparatory teacher as defined in the Principal Regulations or a temporary war-time teacher as defined in Article 3 of the Preparatory and Secondary Teachers' War Service Regulations, 1940, Amending Regulations No. 1, 1942, Statutory Rules and Orders of Northern Ireland, 1942, No. 124. The term shall include :---
 - (1) a teacher absent on leave on war service to whom or in respect of whom a payment is being made by the Governing Body under the provisions of Section 2 of the Teachers' Salaries and Superannuation (War Service) Act, 1939, or under the provisions of Article 6 hereof.
 - (2) a full-time substitute who is being paid at an annual rate of salary.

Clause (b) is amended by the addition of the following :--

In the case of a temporary war-time teacher who is a superannuated teacher his Salary for the purpose of these Regulations shall be deemed to include such pension or pensions as he may have been awarded in respect of teaching service.

EDUCATION.

4.—Article 2 of Statutory Rules and Orders of Northern Ireland, 1942, No. 74, is hereby amended by the cancellation of the rates of temporary war bonus specified therein, as far as service rendered after 30th June, 1942 is concerned and by the substitution of the following rates in respect of service rendered on and after 1st July, 1942 :—

5.—Clauses (2) and (3) of Article 2 of Statutory Rules and Orders of Northern Ireland, 1942, No. 74, are hereby repealed and the following substituted therefor :—

- (1) The bonus shall not be reckonable for the purposes of the Superannuation Scheme.
- (2) For the purposes of these Amending Regulations the term "Salary" as defined in the Principal Regulations shall be deemed not to include any war bonus paid to the teacher under the Principal Regulations as amended.

6.—In the case of a teacher absent on leave on war service whose war service pay equals or exceeds his salary as defined in these Regulations but does not exceed the sum of that salary and the appropriate war Teachers : Certification, Salaries and Employment.

bonus, the Governing Body may if it so decides pay War Bonus at a rate which shall not exceed the difference between the rate of salary of the teacher plus war bonus and his rate of war service pay.

7.—These Regulations shall henceforth be construed with and as forming part of the Principal Regulations.

1.—These Regulations may be cited as "The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2 Amending Regulations, No. 5, 1943."

2.—The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2 (Statutory Rules and Orders of Northern Ireland, 1937, No. 89), hereinafter called the Principal Regulations, are hereby amended as follows :—

3.—Regulation 1 (f) of the Principal Regulations is hereby repealed and the following Regulation substituted therefor :—

1. (f) A "recognized class" is a class of one or more pupils receiving instruction in a subject recognized for the purposes of grants from the Ministry.

4.—Regulation 1 (q) of the Principal Regulations is hereby repealed and the following Regulation substituted therefor :—

 (q) A "full-time teacher" is either a principal or subject to Article 8 hereof, a teacher who is employed in teaching duties by a single governing body (or holding a joint appointment under Article 47 hereof) for at least 18 hours per week, of which not less than 16 hours per week shall be spent in giving instruction to recognised classes which are subject to inspection by inspectors or other officers of the Ministry; provided that if a teacher gives instruction to such recognised classes for at least 10 hours per week and
