

2. The foregoing Direction shall not apply—

- (a) to any wheat which prior to the coming into force of this Direction has been disposed of by any grower in accordance with the provisions of the Home-Grown Wheat (Control and Prices) (Northern Ireland) Order, 1942 (a) or in accordance with the terms and conditions of any licences or authorisations granted by the Ministry of Agriculture for Northern Ireland under authority of that Order ;
- (b) to the use by the grower in accordance with the provisions of Article 3 (1) (c) of the Home-Grown Wheat (Control and Prices) (Northern Ireland) Order, 1942 (a) of any wheat which has been certified as non-millable by the Port Area Grain Committee ;
- (c) to the use of tailings by the grower for feeding to livestock in his ownership, possession or control in accordance with the provisions of Article 3 (1) (b) of the Home-Grown Wheat (Control and Prices) (Northern Ireland) Order, 1942 (a).

3. This Direction shall come into force on the 31st day of March, 1943, and shall apply only to Northern Ireland.

Food (Inspection of Undertakings).

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry.") by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) Order, 1941, (a) made by the Secretary of State under paragraph (1) of Regulation 102A of the Defence (General) Regulations, 1939, and by a Direction given by the Secretary of State for the purposes of the said Order, hereby orders as follows :—

1. In this Order—

- (a) "Specified Undertaking" means any undertaking by way of trade or business concerned in the production, treatment,

keeping, storage, movement, transport, distribution, disposal, acquisition, use or consumption of any specified article ;

- (b) " Specified Article " means any article specified in the Schedule to this Order, or any product or by-product thereof or any mixture containing any one or more such articles.

2. The Ministry may authorise any specified person (hereinafter referred to as " an Authorised Officer ") to enter any premises being premises which he has reasonable cause to believe to be used for the purpose of any specified undertaking, and in the course of such inspection to :—

- (a) carry out any test or other investigation and take samples of any material or product situate at such premises ; and
 (b) examine, and copy any material part of any books, accounts or other records relating to such undertaking.

3. Every person carrying on or employed in connection with any specified undertaking shall furnish the means required by an Authorised Officer as necessary for any entry or inspection and shall produce any books, accounts or records which such Officer may require and shall afford him all reasonable facilities for carrying out any test, investigation, or taking any sample as aforesaid.

4. No person shall obstruct, hinder or molest an Authorised Officer in the exercise of the powers conferred upon him by Article 2 hereof.

5. This Order shall come into force on the 3rd day of May, 1943, and may be cited as the Food (Inspection of Undertakings) (Northern Ireland) Order, 1943.
