

Marketing Scheme (hereinafter referred to as "the Scheme") as defined in section twenty-six of the Bacon Industry Act (Northern Ireland), 1939, (hereinafter referred to as "the Act") and amended by the Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 3) Order, 1939; the Pigs Marketing Scheme (Northern Ireland) (Amendment) Order, 1940; and the Pigs Marketing Scheme (Northern Ireland) (Amendment) (No. 2) Order, 1940:

AND whereas paragraph two of the Schedule to the Act provides that any moneys standing to the credit of the fund established by the Scheme which are not required for the operation of the Scheme or otherwise for the purposes of the enactments applicable to the Scheme shall be applied for the benefit of the pig producing industry in such manner as the Ministry of Agriculture (hereinafter referred to as "the Ministry") may by order direct:

AND whereas by section twenty-three of the Act it is provided that the Ministry may make regulations prescribing anything which is to be prescribed:

Now, therefore, the Ministry, in exercise of the powers conferred upon it by the said Schedule and section of the Act and of every other power enabling it in that behalf, hereby makes the following Order, that is to say:—

1. The Board shall, in respect of the period 1st March, 1943, to 29th February, 1944, pay the sum of £300 to the Trustees of the Agricultural Research Institute of Northern Ireland, Hillsborough, County Down, in respect of research in pig nutrition, and such payment shall be made within two months from the date of commencement of this Order.

2. This Order may be cited as the Bacon Industry (Pig Nutrition Research Grant) Order (Northern Ireland), 1943, and shall come into operation on the date hereof.

## CIVIL AUTHORITIES (SPECIAL POWERS).

### Regulations.

REGULATIONS, DATED 27TH MAY, 1943, MADE BY THE MINISTER OF HOME AFFAIRS UNDER THE CIVIL AUTHORITIES (SPECIAL POWERS) ACTS (NORTHERN IRELAND), 1922 TO 1943.

1943. No. 61.

WHEREAS certain Regulations for the preservation of the peace and maintenance of order are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of section one of the said Act that the Minister of Home Affairs shall have power to make Regulations for making further provision for the preservation of the peace and maintenance of order, and for varying or revoking any provision of the Regulations, and that any Regulations made as aforesaid shall subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule (which Regulations whether contained in the said Schedule or made as aforesaid are hereinafter referred to as "the Regulations.") :

AND WHEREAS it is provided by sub-section (1) of section four of the said Act as amended by section two of the Civil Authorities (Special Powers) Act (Northern Ireland), 1943, that the said Minister may by Regulations made under the first mentioned Act provide that the maximum punishment, on summary conviction, for any such offence as may be specified in the Regulations shall be less severe than the maximum punishment authorised by paragraph (a) of sub-section (1) of the said section four :

NOW, THEREFORE, I, THE RIGHT HONOURABLE WILLIAM LOWRY, K.C., M.P., Minister of Home Affairs for Northern Ireland, in exercise of the powers vested in me by the Civil Authorities (Special Powers) Acts (Northern Ireland), 1922 to 1943, and of all other powers in this behalf thereunto me enabling, do hereby make the following Regulations :—

1. At the end of Regulation 1 (a) of the Regulations there shall be inserted the following paragraph :—

“ Any person convicted of an offence against this Regulation shall on summary conviction be liable to imprisonment for a term not exceeding six months or to a fine not exceeding fifty pounds, or to both such imprisonment and such fine.”

2. At the end of Regulation 1a (b) of the Regulations there shall be inserted the following paragraph :—

“(2) Any person convicted of an offence against this Regulation shall on summary conviction be liable to imprisonment for a term not exceeding six months or to a fine not exceeding fifty pounds, or to both such imprisonment and such fine.”

3. After paragraph (3) of Regulation 1B (c) of the Regulations there shall be inserted the following paragraph :—

“(3A) Any person convicted of an offence against this Regulation shall on summary conviction be liable to imprisonment for a term not exceeding six months or to a fine not exceeding fifty pounds, or to both such imprisonment and such fine.”

4. At the end of Regulation 2 of the Regulations there shall be inserted the following paragraph :—

“ Any person convicted of an offence against this Regulation shall on summary conviction be liable to imprisonment for a term not exceeding six months or to a fine not exceeding fifty pounds, or to both such imprisonment and such fine.”

5. At the end of Regulation 9 of the Regulations there shall be inserted the following paragraph :—

“ Any person convicted of an offence against this Regulation shall on summary conviction be liable to imprisonment for a term not exceeding six months or to a fine not exceeding fifty pounds, or to both such imprisonment and such fine.”

WHEREAS certain Regulations for Peace and Order in Northern Ireland are contained in the Schedule to the Civil Authorities (Special Powers) Act (Northern Ireland), 1922, and it is provided by sub-section (3) of Section 1 of the said Act that the Minister of Home Affairs shall have power to make Regulations (a) for making further provision for the preservation of the Peace and maintenance of Order, and (b) for varying or revoking any provision of the Regulations, whether contained in the said Schedule, or made as aforesaid, and that any Regulations made as aforesaid shall, subject to the provisions of the said Act, have effect and be enforced in like manner as Regulations contained in the said Schedule :

NOW, THEREFORE, I, THE RIGHT HONOURABLE WILLIAM LOWRY, K.C., M.P., Minister of Home Affairs for Northern Ireland, by this Regulation do make further provision for the preservation of Peace and Maintenance of Order, and do hereby as from the date hereof revoke Regulation 26 contained in the said Schedule and order that the following Regulation shall be substituted therefor :—
