ORDER, DATED 30TH JANUARY, 1943, MADE BY THE MINISTRY OF HOME AFFAIRS UNDER THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

In pursuance of the provisions of sub-Section (1) of Section 10 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland), 1935, the Ministry of Home Affairs, after consultation with the County Court Judge and the Resident Magistrate concerned, hereby orders and directs as follows :—

As and from the 1st day of March, 1943, Petty Sessions shall be regularly held in the Petty Sessions District of Keady on the First and Third Thursdays in each month at 11 a.m.

ORDER, DATED 23RD AUGUST, 1943, MADE BY THE MINISTRY OF HOME AFFAIRS FOR NORTHERN IRELAND UNDER THE SUMMARY JURISDICTION AND CRIMINAL JUSTICE ACT (NORTHERN IRELAND), 1935.

In pursuance of the provisions of Sub-Section (1) of Section 10 of the Summary Jurisdiction and Criminal Justice Act (Northern Ireland)

1935, the Ministry of Home Affairs for Northern Ireland after consultation with the County Court Judge and the Resident Magistrate concerned hereby orders and directs as follows :—

As and from 1st October, 1943,

- (a) the boundaries of the Petty Sessions District of Downpatrick shall be altered by the exclusion therefrom of the townlands mentioned in the Schedule to this Order ;
- (b) there shall be established a Petty Sessions District to be called the Petty Sessions District of Ardglass, consisting of the several townlands mentioned in the Schedule to this Order and the Petty Sessions thereof shall be held at Ardglass on the 1st Tuesday in each month at 11 a.m.
