

**FOOD.****Food (Feeding Stuffs) : Oat By-Products.**

ORDER, DATED 14TH FEBRUARY, 1944, MADE BY THE MINISTRY OF AGRICULTURE UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under paragraph (1) of Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) (No. 2) Order, 1943, made by the Secretary of State under paragraph (1) of Regulation 102A of the said Regulations, and of all other powers enabling it in that behalf, hereby orders as follows :—

1. No person shall export from Northern Ireland any oat products or by-products containing more than twenty-five per cent. of fibre :

Provided that this Order shall not apply to oat husks or shudes sold as such.

2. This Order shall come into force on the twenty-first day of February, 1944.

3. This Order may be cited as the Food (Feeding Stuffs) (Oat By-Products) (Northern Ireland) Order, 1944.

THE LIFTING OF POTATOES (PROHIBITION) (NORTHERN IRELAND) ORDER, 1944, DATED 4TH APRIL, 1944, MADE BY THE MINISTRY OF AGRICULTURE UNDER REGULATION 62 OF THE DEFENCE (GENERAL) REGULATIONS, 1939. [Revoked by S. R. O. 1944, No. 44 below.]

REGULATIONS, DATED 30TH MAY, 1944, MADE BY THE MINISTRY OF AGRICULTURE UNDER REGULATION 62 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1944. No. 44.

The Ministry of Agriculture for Northern Ireland (in this Order referred to as "the Ministry.") by virtue and in exercise of the powers

under Regulation 62 of the Defence (General) Regulations, 1939, (a) delegated to it by the Delegation of Emergency Powers (Ministry of Agriculture for Northern Ireland) (No. 2) Order, 1943, (b) made by the Secretary of State under Paragraph (1) of Regulation 102A of the said Regulations, hereby orders and directs as follows :—

1. No person shall lift any potatoes grown in Northern Ireland before 12th June, 1944, except under or in accordance with the terms of a licence issued by the Ministry.

2. No person shall lift potatoes of the varieties mentioned in the first column of the Schedule to this Order before the dates respectively specified opposite those varieties in the second column of the said Schedule, except under and in accordance with the terms of a licence issued by the Ministry.

3. A licence issued by the Ministry under Articles 1 or 2 of this Order shall specify—

- (i) the variety of potatoes to which it relates ;
- (ii) the land on which the potatoes to which it relates are growing ;
- (iii) the date on or after which it shall be lawful to lift the potatoes.

4. Unless written permission to the contrary is issued by the Ministry, the occupier of any land from which potatoes have been lifted on or before 10th July, 1944, shall within 15 days of the date of lifting, sow or plant on the land from which the potatoes have been lifted, a crop to provide food for human or animal consumption, or a crop to produce agricultural or vegetable seeds.

5. In this Order "potatoes" means potatoes grown in Northern Ireland for the purpose of sale.

6. The Lifting of Potatoes (Prohibition) (Northern Ireland) (Order) 1944, (c) is hereby revoked.

7. This Order may be cited as the Lifting of Potatoes (Prohibition) (Northern Ireland) (No. 2) Order, 1944.

## Waste.

ORDER, DATED 26TH APRIL, 1944, MADE BY THE MINISTRY OF COMMERCE  
UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS,  
1939.

1944. No. 38.

The Ministry of Commerce for Northern Ireland (in this Order referred to as the Ministry) by virtue and in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Minister of Fuel and Power hereby orders as follows :—

1. The Waste of Fuel (Northern Ireland) Order, 1943, (hereinafter called "the said Order") shall have effect subject to the following amendment :—

The following paragraph shall be substituted for paragraph 2 :—

- " 2—(1) No person shall allow or cause to be used or consumed any fuel in any premises for the purpose of heating such premises, including the use of central heating plant, until 31st October, 1944.
- (2) No person shall allow or cause to be used or consumed any fuel in any premises for any purpose in connection with a central plant for heating water between the hours of 9.30 p.m. on one day and 6 a.m. of the next succeeding day.
- (3) The provisions of this paragraph shall not apply to premises which are wholly or mainly industrial, to hospitals or institutions for the sick or infirm or aged, to schools or other institutions for children under eighteen years of age, to war time nurseries provided
