ORDER, DATED 30TH MAY, 1944, MADE BY THE MINISTRY OF COMMERCE UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

The Ministry of Commerce for Northern Ireland (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Minister of Fuel and Power hereby orders as follows :—

1. The Coal Supply (Temporary Provisions) (Northern Ireland) Order, 1944, as amended by the Coal Supply (Temporary Provisions) (Northern Ireland) Amendment (No. 2) Order, 1944, is hereby further amended as follows, namely :—

By the substitution in paragraph 1 (a) of the words "during each of the months of March, April, May and June 1944" for the words "month of March".

2. This Order may be cited as the Coal Supply (Temporary Provisions) (Northern Ireland) Amendment (No. 3) Order, 1944.

ORDER, DATED 31ST JULY, 1944, MADE BY THE MINISTRY OF COMMERCE UNDER REGULATION 55 OF THE DEFENCE (GENERAL) REGULATIONS, 1939.

1944. No. 68.

The Ministry of Commerce for Northern Ireland (in this Order referred to as "the Ministry") by virtue and in exercise of the powers under Regulation 55 of the Defence (General) Regulations, 1939, delegated to it by the Minister of Fuel and Power, hereby orders as follows :—

During the period of operation of this Order—

1. The Coal Supply (Northern Ireland) Order, 1942, shall have effect as if there were substituted the following :—

- (a) in paragraphs 7 and 8 the words "two tons" for the words "one ton"
- (b) in the Second Schedule the words "two tons" for the words "one ton".

2. The Coal Supply (Temporary Provisions) (Northern Ireland) Order, 1944, shall have effect as if in paragraph 2 there were substituted the following :—

- (a) the words "seven times" for the words "five times"
- (b) the words "31st July, 1944" for the words "28th February, 1944"
- (c) the words "5 weeks" for the words "3 weeks".

3. This Order shall come into force on the 1st August, 1944, and shall remain in force until the 30th November, 1944.

4. This Order may be cited as the Coal Supply (Temporary Provisions) (Northern Ireland) No. 2 Order, 1944.
