- 1. These Regulations may be cited as "The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2, Amending Regulations, No. 7, 1944."
- 2. The Regulations for Secondary Teachers, Northern Ireland, 1937, No. 2, Statutory Rules and Orders of Northern Ireland, 1937, No. 89, as amended by Statutory Rules and Orders of Northern Ireland, 1941, Nos. 71 and 212; 1942, No. 74; 1943, Nos. 39 and 68; 1944, No. 9, which Regulations as so amended are hereinafter referred to as the "Principal Regulations" are hereby amended as follows:—
- 3. Article 22 of the Principal Regulations is hereby repealed and the following substituted therefor:—
 - 22. That portion of the salary of any teacher, upon an incremental salary scale prescribed under these Regulations equivalent to the commencing rate in the appropriate scale shall be known as the "basic" portion, and the remainder of the prescribed salary as the "incremental" portion of such salary, except that the "basic" portion shall in the case of Principal Teachers be taken to include the Governor's Grant made in accordance with Article 26, and in the case of Vice-Principals and teachers holding Posts

of Special Responsibility, any Special Allowances paid in accordance with Article 27. The "Incremental" portion shall be deemed to include the "Principal's Grant" in the case of Principal Teachers.

4. Article 27 of the Principal Regulations is hereby repealed and the following substituted therefor:—

Special Allowances.

27 (a) In a school with 300 or more pupils of six years of age or over on the roll in the preceding school year (calculated as set forth in Article 43) and where the Governing Body has appointed an assistant teacher to be vice-principal, such vice-principal may be paid an additional allowance, to be known as a "Special Allowance", as follows:—

(b) In Schools with 140 or more pupils of six years of age or over on the Roll in the preceding school year (calculated as set forth in Article 43) and where the Governing Body so desires, it may create posts of special responsibility and may appoint to each such post an assistant teacher from among the staff of the school and pay to him an additional allowance to be known as a "Special Allowance". The number of posts of special responsibility and the maximum rates of Special Allowances that may be recognised under these Regulations are as follow:—

- (c) In schools with 300 pupils and over the number of posts of special responsibility shall be exclusive of the post of vice-principal.
- (d) A teacher may not be allowed for any period a Special Allowance in respect of more than one post.

- (e) The approval of the Ministry must be obtained before a post of special responsibility is recognised under the foregoing terms of this Article.
- 5. These Regulations shall come into operation and have effect as from 1st August, 1944, after which date they shall be construed with and as forming part of the Principal Regulations.
